Summary of key findings for parents

This is a provision that requires improvement

- The provider, who is also the manager, does not follow robust recruitment and vetting procedures. She has not established the suitability of newly employed staff to fully assure children's safety and welfare.
- Partnerships with teachers at the school children attend are not always maximised to fully support and complement children's play, learning and experiences at the club.

It has the following strengths

- Staff build positive relationships with parents. For example, they share information each day about the activities and routines their children take part in. Parents comment that their children are happy and settled and enjoy attending the club.
- Staff promote children's health. For example, they provide healthy snack options, such as fruit and vegetables. Children enjoy the social aspect of mealtimes. They confidently and articulately discuss various topics of interest with their friends.
- Staff encourage and support children well to develop their confidence and self-esteem. They provide meaningful praise and encouragement to help children to feel proud of their achievements. Children feel a secure sense of belonging at the club.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Inspection findings

Effectiveness of leadership and management requires improvement

Although the manager implements rigorous vetting procedures for most staff, she has not fully established the suitability of newly employed staff. She has not obtained Disclosure and Barring Service checks or carried out identity checks for new staff. This does not fully ensure new staff are suitable to work with children. That said, the manager has taken appropriate action to ensure unchecked staff do not have unsupervised contact with children. This minimises the impact on children's safety and welfare. All staff complete regular safeguarding training. They have a sound understanding of the signs that would cause them concern about a child. They know how to refer any concerns to the relevant agencies. Safeguarding is effective. The manager, generally, evaluates the quality of the club and staff's practice well. She consults parents, staff and children and considers their views when identifying areas for improvement. Staff identify training and areas for professional development during supervision meetings. Some staff are working towards a recognised childcare qualification, which helps to build on their knowledge and skills.

Quality of teaching, learning and assessment is good

Staff prepare the environment each day so that it is stimulating and welcoming. They provide children with an interesting range of resources and activities. This helps children to quickly engage in fun activities from the moment they arrive. Staff encourage children to make decisions, lead their own play and express their views. For example, children choose additional resources independently and enjoy helping to plan activities. Staff interact with children effectively, following their interests and supporting their play. They help children to deepen their thinking and ideas. For instance, as children play with play dough, staff use thoughtful questions to deepen children's knowledge of number and shape. Children enjoy expressing their creativity as they use drawing and craft resources.

Personal development, behaviour and welfare require improvement

Weaknesses in the manager's understanding of the legal requirements mean that children's safety and welfare are not fully promoted. Nevertheless, children demonstrate they are happy and they thoroughly enjoy spending time at this warm and friendly club. They form close and secure relationships with staff who care for them. Staff are genuinely kind and caring and they greet children warmly on their arrival. They provide comforting affection and reassurance to younger children, which helps them to settle quickly. Children behave well. They demonstrate a sound understanding of how to manage risks and keep themselves safe. For example, children wear high-visibility vests and walk sensibly in pairs to and from school. Staff motivate children to be physically active, to help them to develop healthy lifestyles. For example, older children play team games and young children run, jump, skip and hop. They develop their physical skills, balance and coordination.
