Summary of key findings for parents

This provision is inadequate

- Managers who are responsible for safeguarding do not have the relevant knowledge or any record of having attended appropriate safeguarding training to keep children safe.
- The provider has not implemented rigorous procedures to check the suitability of all staff who work with children. Some checks and records are not in place. For instance, references from previous employers have not been sought for all employees. In addition, the provider fails to keep a record of all required information about criminal record checks.
- Poor record-keeping further compromises children's well-being and the safe and efficient running of the setting. Staff do not always record children's accidents or injuries.
- Leaders and managers lack oversight of the quality of staff's teaching. They do not have established systems to support staff and strengthen the quality of teaching.
- Staff's plans for children's learning do not focus precisely on what children need to learn next. Activities are not always appropriate to provide challenge for the age range of children involved.

Inspection activities

Inspection findings

Effectiveness of leadership and management is inadequate

Safeguarding is not effective. There are significant weaknesses in staff knowledge and practice that put children at risk. The designated safeguarding officers for the setting have not completed training that enables them to identify, understand and respond appropriately to signs of possible abuse and neglect. They do not have a secure understanding of the signs that a child may be at risk of harm outside the setting. The recruitment and selection procedures are not robust. Although the provider has a list of staff Disclosure and Barring Service check numbers, she does not have a record of the dates these were completed or who carried out the check, as required. Some staff have not been thoroughly vetted as the provider relies on personal recommendations. Accident and incident forms are not always completed for injuries that occur on the premises along with the first-aid treatment provided, as required. The quality of teaching is inconsistent and requires improvement. Staff have recently attended some training. However, the provider does not have a focused programme of performance management to help raise the quality of the provision for children.

Quality of teaching, learning and assessment requires improvement

Staff gain information from regular observations and assessments of children's learning. However, this not used well enough to plan for children's next steps in learning. Consequently, activities are not always well matched to children's abilities or precisely focused on their individual priorities for learning. This does not ensure children of all age groups make enough progress and are consistently engaged and challenged in their learning. The quality of teaching is variable. For example, some staff use recent training effectively to help children begin to close the gaps in the speech and language development. However, at other times staff interactions are loud and rapid and do not give children time to think and formulate a reply. During story time, younger children quickly lose interest and interrupt older children's learning and enjoyment. Nevertheless, at times, children's vocabulary is extended as they learn new words, such as 'steam'. Staff use creative ways to help children understand how the steam can cause mist to form on spectacles. Babies test their own physical capabilities as they begin to walk and move around more freely. They communicate well through expressions and gestures and enjoy peekaboo games as they hide under fabrics and explore textures.

Personal development, behaviour and welfare are inadequate

Weaknesses in leadership and management mean that children's safety cannot be assured. Staff support children to learn about healthy lifestyles and promote good hygiene routines. They teach children to be independent with their self-care skills. For example, staff encourage children to wash their hands before eating and brush their teeth after meals. Children are provided with daily opportunities to gain fresh air and spend some time playing outside. Babies receive messages to help them keep themselves safe, such as not climbing on unsteady toys. Children of all ages build secure relationships with adults and confidently seek them out for reassurance. Staff work in partnership with parents and other agencies, including health visitors and speech and language therapists, to help identify and address concerns about children's development.

Outcomes for children require improvement

Children do not make as much progress as they could from their starting points due to the variable quality of teaching. Some children lack high levels of engagement as staff do not consistently inspire and challenge them. However, most children develop the basic skills and knowledge they need to be ready for starting school. They behave well, build secure relationships and share toys with their friends. Children are developing the physical skills to independently manage mealtimes and toileting.

Little Stompers Day Nursery registered in 2008. It operates Monday to Friday from 7.30am to 6pm for 51 weeks a year. Children are able to attend for a variety of sessions. The nursery also offers care to children aged over five years to 11 years. The nursery employs eight members of staff. Of these, seven hold appropriate early years qualifications, including the manager, who is qualified at level 5.
