Summary of key findings for parents

This provision does not meet requirements

- The childminder has failed to obtain and maintain a paediatric first-aid qualification as required.
- The childminder understands how to assess children's development and monitor their ongoing progress. She is aware of the importance of working in partnership with parents and professionals to plan for children's future learning and help them achieve positive outcomes.
- The childminder knows how to identify that a child may be at risk of abuse or neglect. She knows her responsibilities to protect children. She keeps her safeguarding knowledge up to date and knows the procedures to follow if she has any concerns about a child's welfare.
- The childminder recognises the importance of risk assessment, to identify hazards and to ensure they are minimised or removed to keep children safe.
- The childminder understands the value of self-evaluation and to keep her knowledge up-to-date, for example, through obtaining information from her local authority, her own research and other childminders.
- The childminder explains how she intends to help children to learn about expectations for behaviour and to encourage their independence and self-confidence.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the areas of the childminder's home that are used for childminding and discussed safety.
- The inspector discussed with the childminder her professional development.
- The inspector discussed with the childminder how she plans to meet the requirements of the early years foundation stage and promote children's progress.
- The inspector viewed evidence of the childminder's suitability and the suitability of all adults in the household.
- The inspector discussed safeguarding, checked her paediatric first-aid certificate, looked at policies, procedures and other documentation.
