Information about this children's home

This privately owned children's home offers care for up to five young people who may have a combination of mental health, psychological, emotional and/or complex care needs.

The registered manager is currently working towards his level 5 diploma in leadership and management.

This monitoring visit

This home was judged declined in effectiveness at the interim inspection conducted on 11 March 2019. Following the inspection, the home was served with four compliance notices. These related to shortfalls in leadership and management, medication and the safe recruitment of agency members of staff.

To evaluate the progress being made by the organisation, a monitoring visit was conducted on 16 April 2019.

During the monitoring visit, the registered manager, responsible individual and director for practice development reported that they have put together an action plan to address the shortfalls identified.

Since the last inspection, the registered manager has been provided with a lot of support. This support has enabled a full audit and review of the care of medicines in the home to be carried out. A new complaints process has been introduced by the organisation and means that complaints are now receiving greater managerial oversight.

The work carried out by the organisation has resulted in improvements to the home's systems for monitoring and reviewing the quality of care. This demonstrates that managers are now providing more challenge and oversight of the quality of care that young people receive.

Despite the good progress, there are still shortfalls in the safe recruitment of staff and the manager is still not escalating concerns over delays in staff receiving up-todate care plans for young people from their placing authorities in a timely manner. These continued delays mean that young people continue to have uncertainty over their futures. These two ongoing shortfalls have resulted in two compliance notices being reissued.

This monitoring visit only looked at the progress made against the four compliance notices. All other requirements will be reviewed at the home's next inspection.

A person may only manage a children's home if the person has the appropriate experience, qualification and skills to manage the home effectively and lead the care of children. (Regulation 28 (1)(ii))	15/04/2019
The registered person must recruit staff using recruitment procedures that are designed to ensure children's safety. The registered person may only if an individual is employed by a person other than the registered person to work at the home in a position in which the individual may have regular contact with children, allow that individual to work at the home, if the individual satisfies the requirements in paragraph (3).	30/05/2019
The requirements are that full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1)(2)(b)(3)(d))*	
The registered person must maintain records ("case records") for each child which include the information and documents listed in Schedule 3 in relation to each child and are kept up to date. (Regulation 36 (1)(a)(b))	30/05/2019
