# Summary of key findings for parents

#### This provision meets requirements

- The childminder recognises the importance of working in partnership with parents and other professionals to support children's well-being and educational needs.
- The childminder understands how to provide a safe environment for children. She is aware of the processes to follow if she has concerns regarding children's welfare.
- The childminder understands the importance of observing and checking children's learning to monitor their progress. She knows how to identify what children need to learn next and how to plan for their ongoing progress and readiness for school.
- The childminder understands how to promote children's positive behaviour, and how to help them to develop respect for themselves and others.
- The childminder knows how to promote children's physical health and help them to develop and enjoy healthy lifestyles. The childminder's first-aid certificate is up to date.
- The childminder knows how to evaluate her practice and identify areas for improvement. She develops her professional skills and knowledge.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector had a tour of the home environment with the childminder, and discussed risk assessments that have been undertaken.
- The inspector checked the suitability of all adults living in the household, and discussed safeguarding with the childminder.
- The inspector sampled a range of documents, including records and policies that the childminder will use for childminding.
- The inspector discussed with the childminder her understanding of learning and development requirements, including how she will check children's progress.
- The inspector discussed with the childminder how she evaluates her provision and plans improvements.
