Information about this children's home

The home is registered to provide care and accommodation for up to four children or young people who may exhibit emotional and/or behavioural difficulties together with mild or moderate learning disabilities. The home offers short-, medium- and long-term residential placements for children and young people aged eight to 18 years of age.

The aim is to provide a period of stability to allow children and young people to reflect on their difficulties and make future plans, based on a comprehensive assessment of their social, emotional, behavioural, physical and educational needs and a dynamic care plan.

The manager has been registered with Ofsted since February 2019.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

Since the last inspection, children and young people have made progress in key areas, such as education, behaviour and sleep routines. The majority of the requirements and recommendations set at the last inspection have not been met. Children and young people are now attending health appointments, such as the dentist, the looked after children's nurse and the optician. However, children's and young people's mental health

needs are not being proactively addressed. Children's and young people's past experiences are impacting on their current behaviour, and this is being dealt with on only a superficial level.

The failure to prioritise and ensure that education is available to all children and young people in the home remains a concern. Children and young people have been admitted to this home without a plan of attendance at an education provision. Education assessments have not taken place, which means that education in the home is not based on the child's or young person's level of understanding. Children and young people are mainly refusing to engage in any meaningful education activities. The children and young people in the home have no consistent structure to their day, despite the best efforts of staff.

Behaviour management remains an issue in this home. Children and young people are not given sufficient clear and consistent boundaries to ensure that the home is settled. This has had an impact on other children and young people in the home, who are being kept awake and are upset about the disruption in the home. Behaviours have escalated over the past few weeks, and disruptions have affected other children in the home. The manager has taken appropriate action to end a child's placement.

Pre-placement matching assessments are not robust. The lack of an education provision for one child, combined with children and young people already in the home not attending their education provision, was not taken into account when a child was placed. This poor matching has led to the home being disrupted and a child having another move of home.

The monitoring of the home by the independent person and by the home's manager is not effective. This is not ensuring that children's and young people's plans are promoting improvements. Children's and young people's case files are not updated, and key documents are absent. This does not support staff members' understanding of children's and young people's needs.

Staff make every effort to safeguard children and young people. They follow children and young people when they leave the home, and are a presence when disruptive behaviour is taking place. If they lose sight of children or young people, they follow the robust missing-from-home procedure effectively. Staff have good relationships with children and young people, and this enables the children's and young people's behaviours to be de-escalated when they are angry and upset, so that restraint is not necessary.

The home's Statement of Purpose sets out the home's ethos and overarching principles, which are based upon a theoretical model. However, no evidence of these was seen in children's files, plans or day-to-day practice. In addition, the emphasis on education in the Statement of Purpose has not been realised. The leadership team needs to be more effective in setting the ethos and boundaries within the home to ensure that children make progress.



Children know how to complain in the home and, since the last inspection, the complaints procedure has been updated. Although there have been no complaints since the last inspection, sufficient steps have been taken to strengthen the process.

They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
