# **Summary of key findings for parents**

# This provision is good

- Self-evaluation is effective. The childminder reflects on his and his childminding colleague's practice well, recognising their strengths and areas to develop. He acts on the advice of others, such as other childminding professionals, to help improve practice and children's outcomes.
- Children are visibly happy and enjoy the childminder's interactions. The childminder establishes warm, caring relationships with children and supports their emotional well-being effectively.
- The childminder interacts with children very well. He successfully captures children's attention, for example while reading stories in an enjoyable and enthusiastic way, and supports children's participation effectively. Children of all ages are excited to join in and focus very well.
- Children make good progress from their starting points. They develop their speech well. The childminder successfully supports their language skills, including through reading activities, singing rhymes and helping children to use words in context.
- The childminder's monitoring of children's progress is not regular enough to help him to quickly recognise and address any emerging gaps in their development.
- The childminder does not seek all opportunities to help him to improve aspects of his practice that he recognises as a weakness, to help him boost his skills and knowledge even further.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- strengthen procedures for monitoring children's progress to help swiftly recognise and address any emerging gaps in children's development
- continue to seek opportunities for professional development to enhance the good-quality practice even further.

### **Inspection activities**

- The inspector observed the interactions between the childminder and children as they engaged together in activities.
- The inspector held discussions with the childminder during the inspection about children's care and the activities provided for them.
- The inspector took into account the written views of the parents on the day and engaged with children at appropriate times.
- The inspector viewed documentation during the inspection, including the setting's policies and procedures, and children's attendance registers.
- The inspector held discussions with the childminder about how he reflects on the quality of his service.

# **Inspection findings**

### Effectiveness of leadership and management is good

Safeguarding is effective. The childminder implements clear policies and procedures to help keep children safe. He understands his duty in ensuring children's welfare and knows how to report any concerns if he suspects a child is at risk of harm. The childminder seeks some opportunities to help develop his practice and also involves his childminding assistant in these. For instance, they have attended training to help them support children with special educational needs or disabilities.

# Quality of teaching, learning and assessment is good

Children play in a very welcoming, friendly environment with a broad range of interesting, age-appropriate resources. They enjoy exploring the equipment and toys independently. The childminder knows his key children well. He makes accurate observations of what children can do and successfully uses this information to plan challenging activities to help extend their development. Children enjoy imaginative experiences. For example, they play with toy cars in a toy car park. They learn to think of and share ideas, while developing their communication and social skills with others. Children benefit from the childminder's effective communication with parents. The childminder establishes a two-way flow of information to help support children's development in the setting and at home.

### Personal development, behaviour and welfare are good

Children behave well. The childminder shares his expectations with children. For example, he provides praise when they do things that are positive, to help them understand what acceptable behaviour is. He successfully teaches children to follow good hygiene practices. For instance, children are able to independently wash their hands after using the toilet. Children eat nutritious food and have good opportunities to learn about healthy lifestyles, including during visits to the local allotment. They successfully learn about healthy eating and how to make healthy choices. Children are active and enjoy playing with different equipment outside, such as a toy golf activity, to develop their physical skills and well-being. The childminder regularly assesses risks in all areas that children use, to identify and remove any hazards.

## Outcomes for children are good

All children make good progress and learn a range of skills that prepare them well for their future learning and eventually for school. Children develop good social skills, including interacting with others kindly and confidently. Children move around confidently. They begin to recognise letters in their name and how to count amounts accurately in preparation for school.
