Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This home is registered to provide care and accommodation for up to three young people who have complex needs. The organisation states that it 'offers particular expertise in looking after young people with suspected and enduring mental health needs'. The organisation offers young people support from a variety of therapeutic staff. A private company runs this home. The manager has been registered with Ofsted since July 2018.

This monitoring visit

This home was judged declined in effectiveness at the interim inspection conducted on 20 March 2019. Following the inspection, the home was served with two compliance notices. These related to shortfalls in education and in leadership and management.

This monitoring inspection looked at the progress made against the two compliance notices and requirements raised at the interim inspection. The recommendation raised at the interim inspection was not examined and will be reviewed at the home's next inspection.

The two compliance notices have been met.

The manager has effectively challenged local authorities to ensure that those children not in full-time education are in receipt of suitable alternative education provision. Structures are now in place to ensure that children are supported to engage in constructive activity during the school day.

Since the last inspection, the registered manager is now providing more challenge and oversight of the quality of care that young people receive.



Staff now complete restraint records appropriately, and there have also been improvements in the recording of incidents of children's rooms being searched. The manager has developed systems to allow her good oversight of such records and to enable her to evaluate and improve staff practice.

Despite the good progress, there are still some shortfalls identified at this monitoring inspection. The manager has not devised an effective system to ensure that the monitoring of health and safety checks is adequately conducted. For example, she does not ensure that staff record details about the safe storage of sharp knives, so it is not clear whether this is managed well. As a result, children's safety may be compromised.

Children's health plans are still not adequately completed with up-to-date and relevant health information. One child's health plan does not clearly reflect her health and medication requirements.
