Inspected under the social care common inspection framework

Information about this children's home

This children's home is operated by a private organisation. The home provides care and accommodation for up to three young people who may have emotional and/or behavioural difficulties.

The home's manager registered with Ofsted on 1 May 2019.

A restriction notice, previously in place for this home, has been lifted following this monitoring inspection.

This monitoring visit

This children's home had declined in effectiveness at the last interim inspection on 5 March 2019. Significant shortfalls were identified in respect of the leadership and management regulation. Consequently, a compliance notice was served on 12 March 2019 under regulation 13, to address the identified shortfalls. This monitoring visit has reviewed the progress made in addressing these issues. The other requirements and recommendations raised at the interim inspection have not been reviewed at this monitoring inspection and remain in place.

Two young people have left the home since the last interim inspection. Only one young person remains living at the home at the time of this inspection.

The manager of the home is now registered with Ofsted. Management oversight of risk management has improved considerably. Risk assessments now identify clear strategies for staff to use when addressing young people's risk-taking behaviours. This guidance is used by staff in their practice. Furthermore, staff are now undertaking regular, planned key-work sessions with young people and this includes the input and involvement of external professional agencies, such as Eclipse, the fire

service and the local police community support officers.

The management of young people's free time has improved considerably. Young people now understand that staff need to know where they are going and who they are with when they have free time in the community. Staff show an improved understanding of young people's actual whereabouts, friends and known associates. Staff are now much more vigilant when young people are out of the home. Young people are now engaged in positive activities, which means they are now spending less time unaccompanied in the community and spending more time in the company and presence of the staff.

New incentive programmes have been devised between staff and young people, to support the development of the young people's positive behaviour. The home has moved away from the previous over-reliance on the use of financial incentives and fines and instead uses vouchers as positive rewards. This means that staff have reduced the amount of money being given to, and on occasions, being misused by, young people.

The organisation has now ensured that staff have the appropriate training and skills to meet the specific needs of the young people in the home. Staff have been provided with relevant training, including safeguarding, fire safety, risk management, key working, drug awareness, behaviour management and behaviour de-escalation. In addition, four members of staff are on target to complete the level 3 diploma in July 2019, with the remaining staff already enrolled.

The registered manager has developed a more robust matching process for future admissions to the home. The responsible individual confirmed that the registered manager will have full decision-making responsibility for all new referrals to the home and that the home would not be taking any emergency admissions from any of the organisation's other homes, unless young people were appropriately and suitably matched.

The compliance notice issued under regulation 13 is judged to be met.
