This provision does not meet requirements

- The provider does not have a secure understanding of what changes to information must be notified to Ofsted. She has failed to inform Ofsted of a change of manager, which is a requirement of the early years foundation stage.
- Staff are aware of the possible signs of abuse and neglect and know how to refer any concerns they may have to the relevant agencies.
- Staff have established positive links with the host school to help them to plan activities that complement what the children are learning in school.
- The management team explain how staff receive regular training to help to update their skills and knowledge. Staff are aware of how to implement positive behaviour management strategies.
- Staff understand the importance of working closely with parents and keeping them well informed about their child's time in the club.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
