### This provision meets requirements

- The manager and staff are clear about how to keep children safe and protect them from harm. They know the procedure to follow if there are any concerns about a child's welfare.
- The manager is aware of how to use assessment information to plan and provide learning activities that help children make progress. They understand how to promote positive behaviour and attitudes.
- The manager and staff know how to build partnerships with parents and the host school, to share information about children's learning and individual needs.
- The manager and staff understand the importance of teaching children to adopt healthy lifestyles, including promoting healthy eating. They establish clear hygiene routines and provide opportunities for children to be physically active.
- The manager and staff understand the importance of reviewing and evaluating the provision and seeking the views of parents to identify areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The club is open Monday to Thursday from 3pm until 5pm in term time only. There are two members of staff, including the owner. The owner has an early years qualification at level 3.
