

## Lubavitch Senior Boys' School

**Overall outcome** 

The school does not meet all of the independent school standards that were checked during this inspection

## **Main inspection findings**

Part 1. Quality of education provided

Paragraphs 2(1), 2(1)(a), 2(1)(b), 2(1)(b)(i), 2(2), 2(2)(a), 3, 3(a), 3(b), 3(c), 3(d), 3(e), 3(f), 3(g), 4

- At the previous inspection, six part-time staff shared responsibility for teaching religious studies and for teaching subjects in the secular curriculum. However, the quality of provision varied widely. The good teaching evident in religious studies lessons was not matched in other subjects. Insufficient time was given to secular subjects overall. Time for participation in physical education (PE), music and art was minimal. Curriculum plans were of poor quality and teachers' subject knowledge in secular subjects was weak. Teaching was poorly planned. Pupils were taught the same content, regardless of their different ages and abilities. The expectations of what pupils could achieve, particularly for the most able pupils, were too low. Pupils' work was poorly presented. As a result, pupils did not learn in enough depth in the secular subjects. This was particularly the case in history and science. In mathematics, pupils did not make enough progress.
- The school's action plan outlined a range of actions to develop the secular curriculum. These included the development of curriculum plans and the purchase of resources such as mathematics text books. The plan did not make clear how much curriculum time would be devoted to the secular subjects and to individual subjects such as history, science, PE, music and art. While actions to improve teaching were outlined, it was not made clear how teachers would make use of the new curriculum plans and develop their subject knowledge. Overwhelmingly, these plans referred to the core subjects of English and mathematics. It was also stated that teachers were already using assessment techniques to measure pupils' progress over time.
- Leaders and teachers have had limited capacity to follow through on these actions.
- Detailed schemes of work are not in place for the secular subjects. Time for teaching the secular curriculum has not increased. Overall, insufficient content has been covered in these subjects. Consequently, pupils' learning in secular subjects, including in English, mathematics and science, lacks depth and breadth.



- There are some textbooks for pupils to use in mathematics and English lessons. Overall, however, the quality and quantity of learning resources and classroom environments remain inadequate.
- Teaching remains pitched at the same level for all pupils, regardless of their ages or abilities. There are too few opportunities for pupils to apply their learning. This particularly applies to extended writing in subjects such as English and history and problem-solving in mathematics. Pupils have learned about significant events in history but, as in other subjects, this focuses on content and not the development of subject-specific skills.
- Pupils say they are being encouraged to improve the presentation of their work. The amount of work completed across the secular curriculum is limited. It is mostly structured using worksheets, with few opportunities for pupils to present their work creatively.
- There is no evidence of the use of assessment techniques or the information gained from assessment being used to inform lesson planning and building pupils' knowledge and skills. It is not clear how pupils' work is being assessed over time.
- The requirements of these paragraphs remain unmet.
- Leaders have not ensured that the standards in this part are met.

## Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b)

- At the previous inspection, the arrangements for safeguarding were not effective. There was no designated lead for safeguarding within the school and the arrangements to safeguard pupils were not suitably prioritised.
- The school stated in its action plan that a designated safeguarding leader had been appointed. It also stated that the school's child protection policy, procedures and staff training are now up to date, in line with the latest statutory guidance. Finally, it stated that the required checks for the suitability of staff were all in place and recorded on the school's single central record of recruitment checks. However, leaders have not been rigorous in ensuring that these actions meet the requirements.
- The safeguarding policy provided during the inspection had been obtained from another school. This policy was dated February 2018 and had not been updated to have full regard for the Secretary of State's September 2018 guidance 'Keeping children safe in education'. The designated safeguarding lead named in this policy is the headteacher of the school from which the policy had been obtained. No mention was made of staff or pupils at this school. Nonetheless, the staff spoken to during this inspection were clear they had seen an updated policy but could not locate it. They showed secure understanding of their duties and responsibilities to safeguard pupils in line with current guidance.
- At the current time, the interim headteacher is also the designated safeguarding lead. His training is current and at the appropriate level. His work at the school is on a part-time and temporary basis and there is no deputy in place.
- Scrutiny of the school's single central record showed that not all the checks for the



suitability of staff were in place.

■ The requirements of this paragraph remain unmet.

#### Paragraph 11

- At the previous inspection, the requirements for the health and safety of pupils both on and off the school site were met.
- At the time of this inspection, a member of staff accompanied some boys on a school trip to New York. The formal risk assessment for this trip was poorly completed. It did not fully detail or accurately reflect arrangements for travel and accommodation. Discussions with leaders and pupils established that suitable arrangements were in place to ensure the health and safety of the boys while they were away. However, the school's overall systems for ensuring pupils' health and safety while on educational visits are judged as inadequate.
- During the school day, including when at the synagogue, pupils are well supervised by staff. While the premises are jaded, no immediate health and safety concerns were identified during the inspection. The day-to-day management of health and safety and fire safety is adequately undertaken by staff from the junior school, who share use of the premises.
- The requirements of this paragraph are now unmet.

## Paragraph 15

- Since the previous inspection, the school's admissions register has not been rigorously maintained. The interim headteacher has ascertained which boys have left the school and their destination school, and has received written confirmation of their enrolment. However, this information has not been entered on to the admissions register.
- The attendance register is kept daily. However, there is no indication in the register of which pupils have left.
- The admissions and attendance registers are kept electronically. It is not clear how the school is fulfilling the requirements for regular back-up, either electronically or by printed copy.
- The requirements of this paragraph are now unmet.
- Leaders have not ensured that the standards in this part are met.

### Part 4. Suitability of staff, supply staff and proprietors

### All paragraphs

- At the previous inspection, the single central record and other records showed that staff had been appointed without checks being made of their qualifications, references or their right to work in the United Kingdom.
- The school stated in its action plan that the single central record was now compliant following an audit and update. However, while right to work, prohibition from teaching checks for teachers and reference checks are now shown on the single central record, some omissions remain.
- There is no record of barred list checks. Furthermore, where Disclosure and Barring Service checks have been transferred from a previous employment, the required barred



list check has not been made. The date on which further checks of suitability were carried out is not recorded. The single central record showed no evidence of qualification checks. All of the required checks for the interim headteacher have been undertaken but they are not recorded on the school's single central record.

- Checks for the trustees are in place and recorded on the single central record. However, there is no record of checks being undertaken or being in progress for the new governors. A prohibition from management check has not been undertaken for one member of staff.
- The school does not make use of supply or agency staff.
- The following paragraphs remain met: 18(2)(c)(i), 18(2)(d), 20(6)(c), 21(2), 21(3(a)(i), 21(3)(a)(v) and 21(3)(a)(vi).
- The following paragraphs are now met: 18(2)(c)(ii), 18(2)(c)(iii), 21(3)(a)(vii) and 21(3)(b).
- These paragraphs remain unmet: 18(2), 18(2)(a), 18(2)(b), 18(2)(c), 18(2)(c)(iv), 18(2)(e), 21(1), 21(3), 21(3)(a), 21(3)(a)(vii), 21(3)(a)(viii), 21(3)(a)(iv) and 21(3)(a)(v).
- These paragraphs are no longer met: 18(3), 20(6), 20(6)(a), 20(6)(a)(i), 20(6)(a)(ii), 20(6)(b), 20(6)(b)(ii), 20(6)(b)(iii), 20(6)(b)(iii), 20(6)(c), 21(3)(a)(ii), 21(3)(a)(iii) and 21(6).
- Leaders have not ensured that the standards in this part are met.

#### Part 5. Premises of and accommodation at schools

Paragraph 23(1), 23(1)(c)

- At the previous inspection, suitable changing accommodation and showers were not provided for pupils.
- The school has not fulfilled its intended action that suitable changing and shower facilities would be available and in use from January 2019.
- The requirements of this paragraph remain unmet.
- Leaders have not ensured that the standards in this part are met.

### Part 6. Provision of information

Paragraph 32(1), 32(1)(c)

- At the time of the previous inspection, it was not clear if the school's safeguarding policy was made available to parents and carers.
- The school's current safeguarding policy was not available for the inspection. Furthermore, there was no evidence of how the policy is made available to parents.
- The requirements of this paragraph are now unmet.
- Leaders have not ensured that the standard in this part is met.



## Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a), 34(1)(b), 34(1)(c)

- At the previous inspection in June 2018, leaders had not made sure that the school met the requirements of the independent school standards. There were significant gaps in the quality of education provided for pupils, in the school's safeguarding procedures and in the checks made on the suitability of staff to work with children. The school's leaders lacked the necessary capacity and expertise to fulfil all of their duties effectively.
- The school's action plan outlined a range of actions to improve the leadership and management of the school. These included the appointment of a consultant executive headteacher, director of general studies, leadership consultant and additional clerical support. However, these have not been realised. Leadership support from another school was in place for one term, during which some work on policies was undertaken. However, this support is no longer in place.
- The school's proprietors have worked to build capacity for the school through the appointment of new governors and an interim headteacher. Together, they have a clear vision and ambition for the school. The new governors are rapidly gaining a sound understanding of the school's current shortcomings and are beginning to drive improvement.
- The interim headteacher has worked to establish the school back at its registered premises and ensure pupils' welfare and safety. For example, he has put in place actions to support and improve pupils' behaviour and provide safeguarding training for school staff. He has identified a range of other actions that need to be taken for the school to meet the independent school standards. However, these have yet to be addressed. Consequently, at the current time, the school leadership continues to lack the capacity, the necessary systems and the administrative support to secure the required improvements.
- Leaders had already identified that the checks made on the suitability of staff to work with children are not fully recorded on the single central record and that checks on the governors were required. Also, they had identified that the admissions and attendance registers had not been updated. While actions to address these have started, they have not been completed.
- Leaders have not ensured that the standard in this part is met.



## **Compliance with regulatory requirements**

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

#### Information about this school

- Lubavitch Senior Boys' School is registered to admit up to 40 boys between the ages of 11 and 13 years. The school was registered in January 2017. All pupils are from Orthodox Jewish backgrounds.
- The school shares its premises with Lubavitch Junior Boys School, an academy school which is part of the Lubavitch Multi Academy Trust. However, between September and December 2018, the boys were taught at the premises of Lubavitch Yeshiva Ketanah of London. The school was closed to pupils between the beginning of January and mid-February 2019.



- No pupils are deemed to be disadvantaged or looked after by the local authority.
- Currently, no pupils have an education, health and care (EHC) plan.
- The pupils start each day with prayers at the nearby Lubavitch Synagogue in Stamford Hill.
- The acting headteacher in post at the June 2018 inspection is now the deputy headteacher. Since mid-February, an interim headteacher has been leading the school on a part-time basis. This arrangement is due to end on 12 April 2019.
- Three proprietors oversee the school's strategic leadership. Three new governors, all parents of pupils at the school, have recently been appointed to strengthen the school's strategic leadership.
- The school does not make use of any alternative or off-site provision.
- The school's first and most recent full inspection took place in June 2018, when the overall judgement was inadequate. A number of the independent school standards were judged as unmet. These related to the quality of education, safeguarding, the premises and the school's leadership and management.



## Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- At the request of the Department for Education (DfE), the inspection was carried out without notice. This was the school's first monitoring inspection since its previous standard inspection in June 2018, when some of the independent school standards were not met. The overall effectiveness of the school was judged as inadequate.
- The school submitted an action plan in December 2018, which detailed how it intended to meet the unmet independent school standards identified in the June 2018 inspection. The plan was evaluated on 7 January 2019 and judged to be unacceptable.
- The inspector was asked to report against unmet requirements within parts 1, 3, 4, 5 and 8 of the independent school standards. In addition, the inspector was asked to check the school's safeguarding policy, its implementation and its availability to parents.
- The inspector met with the interim headteacher, who is also the designated safeguarding lead and current leader of the Kodesh (Jewish) curriculum. She met with two of the school's teachers and spoke briefly to the school administrator for the junior boys' school.
- The inspector also held telephone conversations individually with the chair of the trustees and a parent governor.
- The inspector met with a group of pupils to talk about their learning, safety and well-being, and to find out their views of the school.
- The inspector checked the school's single central record. The safeguarding policy, other policies and documentation were also scrutinised. This included the risk assessment of the overseas trip taking place at the time of the inspection.
- The inspector walked around the school's premises. She made visits to lessons at various times to check on the quality of education provided. She also scrutinised pupils' books. Pupils were briefly observed in the playground at both breaks and lunchtimes.
- There were 15 responses to Ofsted's online survey, Parent View, at the time of the inspection. The most recent entry was dated 20 June 2018, the date of the previous inspection.
