Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraphs 2(1), 2(1)(a), 2(1)(b), 2(1)(b)(i), 2(i)(b)(ii)

- The previous inspection found that leaders were developing the curriculum but that it did not build on pupils' knowledge and skills well enough.
- There has been an improvement in the use of assessment and teachers' questioning to probe pupils' knowledge. Leaders have introduced a new computer-based method of curriculum planning. However, pupils' work over time in a range of subjects remains disorganised. This makes it difficult to identify the progress they are making. As a result, the implementation of the curriculum is not effective enough to meet the requirements of the standards.

Paragraphs 2(2), 2(2)(e), 2(2)(e)(i), 2(2)(e)(ii), 2(2)(e)(iii)

- The September 2018 inspection found that pupils of secondary school age were not receiving accurate, up-to-date and impartial advice on a broad range of career options.
- Leaders have ensured that pupils in Years 8 and 9, together with their parents, have received guidance on subject options for key stage 4. Pupils told inspectors they remembered this and found it useful. Leaders also now use published guidance to determine how they intend to provide careers advice. However, they have not ensured that a plan or programme is in place indicating how and when all secondary-aged pupils will receive impartial careers guidance on a broad range of career options. Therefore, these standards remain unmet.

Paragraphs 3, 3(a), 3(b), 3(c), 3(d), 3(e), 3(f), 3(g)

- At the previous inspection, teachers' use of assessment and resources did not match curriculum plans. The work they typically set for pupils was undemanding and lacked challenge.
- Leaders do now ask teachers to regularly assess pupils' progress. Teachers' use of assessment and questioning to probe pupils' knowledge has improved. However, the measures of success that teachers use when assessing pupils' learning do not identify specific enough skills and knowledge. As a result, they cannot effectively gauge how well pupils are learning.



- The work and objectives teachers set pupils continue to be too similar despite pupils' range of abilities. As a result, pupils' work over time indicates that the teaching does not make effective enough use of resources or time to meet the standards.
- Leaders told inspectors that they are checking on the quality and impact of teaching more systematically. Despite this, a number of the pupils' workbooks leaders gave to inspectors contained poorly presented work and were damaged. These books demonstrate that teachers' expectations of their pupils' learning remain inconsistent.
- The standards in this part of the regulations continue to be unmet.

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 7(a), 7(b)

- At the time of the previous inspection, the implementation of the safeguarding policy and the training staff had received about guidance were poor.
- Since the previous inspection, further training, such as on the 'Prevent' duty, has been completed. However, the current safeguarding policy continues to make no reference to the most recent statutory guidance. Therefore, these standards remain unmet.

Paragraph 12

- At the time of the previous inspection, it was found that leaders were not complying with the Regulatory Reform (Fire Safety) Order 2005 because associated tests were not carried out regularly by a qualified assessor.
- The proprietor ensured that a fire risk assessment was carried out by a qualified assessor in October 2018. Leaders have taken some actions as a result of the recommendations of this assessment. Records show that fire evacuation drills have taken place, which pupils remember and understand. Therefore, this standard is now met.

Paragraph 15

- At the time of the September 2018 inspection, it was reported that leaders were not maintaining admissions and attendance registers in accordance with the Education (Pupil Registration) (England) Regulations 2006.
- Inspectors verified that leaders have now created an admissions register. However, this includes seven more names than the number of pupils currently on roll. Leaders explained that these pupils had since left the school. The register contains provision for recording the date pupils leave the school. However, these dates have not been added to the register for these pupils. Leaders were able to later provide separate details of the date of leaving and destination of all seven leavers. However, they are not using their own register to record this information in one place as required. Therefore, this standard remains unmet.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2), 18(2)(a), 18(2)(b), 18(2)(d), 18(3), 20(6), 20(6)(a), 20(6)(a)(i), 20(6)(b)(ii), 20(6)(b)(ii), 20(6)(b)(iii), 21(1), 21(3), 21(3)(a), 21(3)(a)(iii), 21(3)(a)(iiii), 21(3)(a)(iiii), 21(3)(a)(iiiii), 21(3)(a)(v), 21(3)(b), 21(6), 21(7), 21(7)(a), 21(7)(b)



- At the time of the previous inspection, it was found that the school's checks on the suitability of staff were not robust enough to meet the standards. There was a record of these checks, but leaders were not able to assure the inspectors that all staff had a valid enhanced certificate from the Disclosure and Barring Service (DBS).
- School records show that a number of teachers have applied for an enhanced DBS clearance in April 2019. However, no outcomes of these applications have yet been received. This applies to some staff for whom leaders have only limited disclosure information.
- The school's single central record indicates that the headteacher verified all disclosure records as acceptable on 1 September 2018. This pre-dates the last inspection and has not been updated as a result of any actions taken following the inspection findings.
- The school's single central record also inaccurately records that additional checks required by the standards on those holding leadership and management positions in the school are not applicable to the headteacher.
- There are no records relating to the members of the governing body on the document that leaders showed inspectors, other than those related to the headteacher.
- The standards in this part of the regulations continue to be unmet.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a), 34(1)(b), 34(1)(c)

- At the previous inspection, a number of the independent school standards were found to be unmet.
- The proprietor has not ensured that school leaders have effectively tackled the weaknesses identified at the previous inspection. As a result, all but one of the standards previously found to be unmet remain unmet.
- The standards in this part of the regulations therefore remain unmet.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- This is an Islamic school for boys and girls. The school is registered for 81 pupils aged six to 16; there are currently 127 on roll aged five to 14, which exceeds the number for which it is registered. The school plans to provide education for Year 10 pupils from September 2019, and Year 11 pupils in September 2020.
- The school was last inspected in September 2018, when it was judged to be inadequate. The inspection judged that the school did not met the Education (Independent School Standards) Regulations 2014 and associated requirements.



- The proprietor subsequently submitted an action plan to the regulating authority which was found to be unacceptable by Ofsted in February 2019.
- Pupils come from a range of cultural backgrounds and speak English as an additional language.
- The school does not have any pupils who have special educational needs or an education, health and care plan.
- The school does not use alternative providers.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This inspection was carried out with no notice on the recommendation of the regulating authority.
- Inspectors visited lessons with school leaders to look at pupils' work, talk with pupils and consider how resources were being used by teachers.
- Inspectors conducted a scrutiny of pupils' work in a range of subjects and looked at the curriculum plans leaders are currently using.
- A range of other documents were considered, including reports from fire risk assessments, safeguarding policies and other safeguarding records. These included the records kept of checks on the suitability of staff.
- The school's admissions register was also inspected.

- 21(3)(b) in relation to each member of staff ("S"), whether a check was made to establish whether S is subject to a prohibition order or an interim prohibition order,



including the date on which such check was completed.

- 21(6) The information referred to in this sub-paragraph is, in relation each member ("MB") of a body of persons named as the proprietor appointed on or after 1st May 2007, whether the checks referred to in paragraph 20(6)(b) were made, the date they were made and the date on which the resulting certificate was obtained.
- 21(7) The information referred to in this sub-paragraph is, in relation to each member of a body of persons named as the proprietor in post on 1st August 2007 who was appointed at any time before 1st May 2007-
- 21(7)(a) whether each check referred to in sub-paragraph (6) was made; and
- 21(7)(b) whether an enhanced criminal record certificate was obtained, together with the date on which any check was completed or certificate obtained.
