## **Summary of key findings for parents**

### This provision does not meet requirements

- The childminder does not have a valid appropriate paediatric first-aid certificate. This means she does not have up to date knowledge to enable her to treat children's minor accidents or injuries. This is a breach of requirements for the Early Years Register and of the Childcare Register.
- The childminder understands the importance of working in partnership with parents and other settings children may attend, to provide continuity of care and learning.
- The childminder has a good understanding of safeguarding procedures and confidently describes the signs and symptoms that may indicate that a child is at risk of harm. She is fully aware of the correct procedures she would follow if she has concerns about a child's safety and/or welfare.
- The childminder provides a good range of resources both indoors and outside. These are suitable for children of various ages and stages of development.
- The childminder knows how to plan a range of activities that supports children's interests and builds on what they know and can do. She understands the importance of monitoring children's progress and identifying their next steps in learning.
- The childminder understands the importance of gathering information from parents to meet children's care needs and the need to keep them informed about their children's progress.
- The childminder knows to manage children's behaviour positively and support them to recognise each other's differences.
- The childminder knows how to promote children's health and well-being. She understands the importance of promoting a healthy and balanced diet, and of providing children with daily access to fresh air and encouraging regular exercise outdoors.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector discussed with the childminder her understanding of safeguarding and child protection procedures.
- The inspector discussed how the childminder intends to share information with parents to support their children's care, well-being and learning.
- The inspector discussed how the childminder intends to plan and deliver educational programmes to help children learn and develop.
- The inspector reviewed the childminder's documentation and evidence of the childminder's insurance.
