# This monitoring visit

An emergency suspension notice was issued to the provider on 25 March 2019 along with three compliance notices.

At the monitoring visit on 2 May 2019, it was identified that the registered provider has taken sufficient action to meet the compliance notices raised under regulation 6 and regulation 14 compliance notices.

Despite this, the registered provider had not taken sufficient action to meet the required actions set out in the compliance notice raised under regulation 13. Because of this, a further compliance notice was issued under regulation 13, the leadership and management standard.

This monitoring visit was completed to review the progress made against the compliance notice.

Staff have completed several training courses since the last inspection. This means that staff now have the skills and knowledge to deliver care to young people in line with the home's statement of purpose.

Specifically, enough staff are now trained to be able to safely administer medication to young people. All staff are now trained in the safe moving and handling of young people. Similarly, staff are trained to feed young people who are not able to take food orally.

Staff have now completed the training needed to enable them to promote young people's needs and keep them safe.
