This provision meets requirements

- All staff are confident in their roles and responsibilities to safeguard children. They know the procedures to follow should they have any concerns about a child's well-being. Staff are aware of how to identify any children who may be at risk of being exposed to extreme ideas or behaviours.
- Staff know to risk assess the premises and outdoor environment. They understand the importance of providing children with a safe environment in which to play. They have taken effective steps to meet previous actions to ensure the safety of the premises and close supervision of children.
- Staff know how to encourage children's positive behaviour, supporting them to develop friendships, share, take turns and show respect to others.
- Staff understand the benefits of providing children with daily opportunities to be physically active. They know to plan activities that help children learn about the importance of healthy eating and how to maintain their good health.
- Staff understand the importance of working with parents and schools children attend, to promote continuity in their care.
- The staff team knows to implement systems to monitor and evaluate the ongoing effectiveness of the service on offer.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.



Inspection activities

- The inspector discussed with the manager how she evaluates practice, particularly in relation to safeguarding children.
- The inspector spoke with the manager on how the staff team plan a range of play experiences provided for children.
- The inspector viewed areas of the premises and outdoor environment used by children.
- The inspector sampled a range of documents, including staff suitability, child protection procedures, risk assessments and children's records.
