Summary of key findings for parents

This provision meets requirements

- The provider has a good understanding of his role and responsibility to keep children safe and protected from harm. He is aware of the possible indicators of abuse and knows the procedure to follow to report any concerns about the welfare of a child. All staff undertake regular training to help them keep their knowledge and skills up to date.
- The provider understands how to use policies and procedures to help keep children safe and secure, including the use of risk assessments and checks on staff practice.
- The provider and staff know how to plan and provide a range of activities that build on children's interests and complement their learning in school.
- The provider fully understands the importance of providing children with ample opportunities to support their physical well-being. For example, children have opportunities to enjoy fresh air and exercise, helping to promote healthy lifestyles.
- The provider demonstrates that he has a good knowledge of positive methods to use to effectively manage children's behaviour.
- The provider recognises the benefits of working with parents and carers. He knows how to seek the views of children and parents when evaluating the club's effectiveness. The provider recognises the value of evaluating club practice in order to help to identify strengths and areas for development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held a meeting with the provider to discuss their understanding of the early years foundation stage.
- The inspector looked at documentation relating to staff suitability, safeguarding and children's information records.
- The inspector had a tour of the areas of the premises used by children and looked at the equipment and toys available.
- The inspector discussed the safeguarding and welfare requirements with the provider.

YMCA Childcare – Melbourne Park registered in 2017. The club operates in Nottingham and employs four members of childcare staff. The club opens Monday to Friday during term time. It operates a breakfast club from 7.30am to 8.45am. An after-school club operates from 3.15pm to 6pm.
