Summary of key findings for parents

This provision is outstanding

- The manager and staff monitor and track children's individual and specific group progress extremely well. This enables them to rapidly identify any gaps and provide outstanding support for children of all ages and abilities to exceed their learning expectations.
- Children have amazing opportunities to learn about the world around them and explore and investigate. Children learn about recycling and how to help the environment. They research 'under the sea' and explore water play, where they remove plastic out of the water 'that will kill the fish and pollute the ocean'.
- All children are exceptionally confident to communicate their ideas. For instance, they are extremely enthusiastic when using visual props to create their own tales: they share with their friends with great excitement and pride.
- Staff establish extremely positive partnerships with parents and keep them incredibly well informed in their children's learning. For example, they routinely share children's learning experiences and regular training with them, such as inviting parents in to learn about the importance of keeping their children and themselves safe while using the internet.
- Staff get to know children's individual personalities and interests exceptionally well. They establish incredibly secure and trusting relationships with them. Children have outstanding levels of positive well-being, self-respect and self-worth.
- Children are extremely independent. They have an active role in adding to the activity plans and risk assessing the setting. They choose their own play with exceptional confidence.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

■ strengthen the already very good opportunities children have, to develop their skills and interest in technology even further.

- The inspector looked at written documentation, including a sample of the policies and procedures, risk assessments and staff training records.

Inspection findings

Effectiveness of leadership and management is outstanding

The manager and staff evaluate their practice to an exceptional standard. For example, they observe each other teach and interact with children daily, setting extremely purposeful and challenging targets. This helps staff to ensure that they continue to provide children with outstanding learning opportunities. The manager closely monitors the consistency of care and teaching that staff provide for children. Staff implement new 'challenges of the week' for children and this helps keep children fascinated to learn and problem solve with exceptional confidence. The manager identifies a need to enhance children's interest and skills in technology even further. Safeguarding is effective. The manager and staff have an incredibly good knowledge and understanding of the safeguarding policies to help protect children's safety and welfare. Children learn how to keep themselves safe and are enthralled in activities that require excellent levels of maturity. For example, they learn about how to be safe around water during regular 'splash days' with paddling-pool activities.

Quality of teaching, learning and assessment is outstanding

Staff help prepare children to manage the eventual move on to school extraordinarily well. Children read and write simple sentences with extreme levels of confidence. Older children can differentiate between capital letters and lower case and all can recognise and write both their first and surnames. Staff build astonishingly good partnerships with staff at other settings children also attend, to provide them with an outstandingly positive approach to their shared care and learning. For instance, they observe children and make next steps in their learning together. Staff expertly extend children's interests in amazingly interesting ways. For instance, children who are fascinated about planes, go on to enjoy a visit from a pilot.

Personal development, behaviour and welfare are outstanding

Staff are inspirational role models. Children are extremely polite, and their behaviour is impeccable. Children have outstanding opportunities to challenge their physical skills. For example, they have regular cricket, tennis and gymnastic lessons and learn skills, such as how to safely do a forward roll. Children have incredibly good opportunities to develop a good understanding of healthy eating. For instance, they are enthusiastic to make extremely interesting produce, such as vegetable soup, and spinach and watermelon lollies. Children gain outstanding respect and understanding for other people's similarities and differences. For instance, all children have regular language lessons and learn different words, such as 'hello' in French and Mandarin.

Outcomes for children are outstanding

All children make outstanding progress. Children explore more complicated ideas, such as still-life drawings. All children learn about different artists such as Pablo Picasso. They also learn about different types of music and rhythm. They are enthralled in listening too and playing notes on the piano, cello, trumpet and violin. Children have outstanding opportunities to develop their mathematical skills and learn more complicated ideas such as estimation and volume.

The Rocking Horse Montessori Kindergarten registered in 1989. It is located in Tunbridge Wells, Kent. The setting is open Monday, Tuesday, Thursday and Friday from 8.30am to 1.30pm and on Wednesday from 8.30am to 4pm, term time only. The provider receives funding to provide free early education for children aged three and four years. the setting employs 7 members of staff, of which 5 members of staff hold level 3 qualifications or above. This includes one member of staff who holds a level 4 and two members of staff who have an early years degree at level 6.
