Summary of key findings for parents

This provision meets requirements

- The childminder understands how to support children's learning and development. She understands the importance of completing observations to assess and monitor children's progress. She describes how she will provide a suitable range of learning experiences to help children make good progress in their development.
- The childminder has a confident knowledge of safeguarding. She understands the signs that may indicate a child's welfare is at risk and knows the procedures to follow to report any concerns or allegations to the relevant authorities. She understands the importance of minimising risks to children, helping to prevent accidents.
- The childminder can explain how she would encourage children to develop independence through their play and daily routines. She is committed to ensuring that children's behaviour is good and that they are considerate of each other and the environment.
- The childminder has a clear understanding of the importance of working in partnerships with parents, professionals and other settings children may attend. She demonstrates how she shares assessments, next steps in learning and other useful information to ensure continuity in children's care and learning.
- The childminder knows how to encourage children to maintain a healthy lifestyle which supports their physical development.
- The childminder understands how to evaluate her practice. She actively develops her professional knowledge and skills to help her make improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at, and discussed a range of records with the childminder, including policies and procedures, evidence of qualifications, her suitability and that of household members.
- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector had a discussion with the childminder about her knowledge and understanding of the safeguarding and welfare requirements.
- The inspector and the childminder discussed how she reflects on her practice and brings about improvements in the quality of provision.

The childminder registered in 2012. She lives in Feltham, in the London borough of Hounslow. She operates all year round from 7am to 7pm, Monday to Friday, except for bank holidays and family holidays.
