## Summary of key findings for parents

#### This provision meets requirements

- The childminder understands how to safeguard children. She knows the signs that would alert her to any concerns. She fully understands the actions she would need to take to follow up any issues to promote children's welfare.
- The childminder knows the importance of risk assessments to help her to promote children's safety in the home and when on outings. The childminder's home is free from hazards.
- The childminder understands how to promote children's good health and well-being. She knows the importance of teaching children about healthy lifestyles through daily discussions, exercise and providing balanced, nutritious meals and snacks. She also understands how to positively manage children's behaviour.
- The childminder understands the need to work in partnership with parents, other early years settings and key agencies to maintain a consistent approach to children's care, learning and development.
- The childminder has an extensive, suitable selection of play materials and resources to promote children's learning and development. She understands the importance of using observations and assessments of children's progress.
- The childminder recognises the importance of evaluating her provision and undertaking training to improve the quality of her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector discussed the safeguarding and welfare requirements with the childminder and took into consideration the suitability checks.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector had a tour of the areas of the premises that will be used by children and discussed the equipment and toys available.
- The inspector discussed the policies and procedures with the childminder and viewed documentation that she will use when caring for children.
