# **Summary of key findings for parents**

## This provision is inadequate

- The provider does not monitor the quality of provision. Consequently, several registration requirements are not met. Some mandatory records are not kept, such as for recruitment.
- Staff do not have a clear understanding of wider safeguarding issues. Vetting and recruitment procedures are weak. The provider does not ensure all staff working with children are suitable. This compromises children's welfare.
- The provider does not adequately consider risks to children or remove potential hazards to children to help keep them safe.
- Appropriate arrangements are not in place to monitor staff performance. The provider does not identify weaker aspects of staff practice, to ensure all children receive experiences that secure their good progress.
- Staff do not use their observations and assessments to plan children's next stages in learning, nor do they involve parents. Progress checks for children aged between two and three years are not in place to help identify when children are not making the expected progress.
- Deployment of staff is poor, resulting in children not being engaged or safe. Staff miss key chances during daily routines and activities to promote children's communication and language skills.

## It has the following strengths

- Children are happy, settled and approach staff who are warm and kind towards them.
- Parents describe staff as 'approachable' and 'friendly'.

# **Inspection findings**

## Effectiveness of leadership and management is inadequate

There are significant failings in meeting registration requirements for this newly registered setting. Safeguarding is ineffective. The provider has completed 'safer recruitment' training. However, this has not been effective. Staff who have not been checked for their suitability to work with children are left unsupervised to manage children's intimate care routines. This puts children at potential risk of harm from unsuitable people. Staff understand the local authority reporting procedures to report welfare concerns. However, they are not aware of safeguarding issues, such as the 'Prevent' duty guidance and female genital mutilation. Some staff are not vigilant of hazards and risks posed to children's safety. The provider does not monitor safeguarding practice or the quality of teaching to ensure children are safe or to eliminate inconsistencies in staff practice.

## Quality of teaching, learning and assessment is inadequate

The quality of teaching is weak. The system in place to monitor and plan activities for children is not effective. Staff do not follow children's interests or use their observations of what children can do to plan for their individual learning and development. Staff do not review or assess children's progress between two and three years and do not share a short summary with their parents, as required. As a result, staff have not established if children are developing appropriately to get the help they may need to progress as they should. Some children run around and are not engaged in any purposeful activity or play. Staff miss opportunities to promote children's communication and language effectively. During 'Davening', a circle time activity where Jewish children learn the first prayer, 'Modai', as well as other prayers, staff race through the prayers and do not engage children effectively. This results in children not participating and becoming distracted, and does not teach them to become effective learners.

# Personal development, behaviour and welfare are inadequate

The weaknesses in safeguarding compromise children's welfare and safety. Staff fail to recognise risks or teach children about safe behaviour. Some children routinely climb on stacked chairs because staff do not teach children about the risk of injury. During the changeover of activities, the atmosphere is chaotic, as staff focus on domestic tasks rather than the children who are not engaged in play and learning. Staff expect all children to lay on a sleep mat, as part of the routine, including children who do not require a rest and have lots of energy. As a result, some children become restless. Children have daily opportunities for outdoor play, and they enjoy fresh air and active play. They have access to fresh fruit and drinking water, which contributes to their positive health and well-being.

## **Outcomes for children are inadequate**

Weaknesses in the quality of teaching compromise outcomes for children. Children are unable to build on and extend their learning. This means they do not make as much progress as they should. Routines and teaching do not take into account the needs of individual children. As a result, children are not well prepared for their next stage of learning.

Happy Tots registered in 2018 and is located in the London Borough of Barnet. The setting opens each weekday from 8.45am to 3.30pm, term time only. It receives funding for provision of free early education, including funding for two-year-old children. The setting employs six members of staff to work directly with the children. Of these, three staff members hold childcare qualifications, including one who holds qualified teacher status.
