Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraph 3, 3(a), 3(c), 3(d), 3(e), 3(g)

- The previous inspection found that teachers were not planning learning well enough. They did not develop pupils' knowledge and skills well enough. Teachers did not have high enough expectations of pupils' work and set work that was too easy for some pupils. Not all teachers showed good knowledge of their subjects. The teaching of mathematics, in particular, was weak.
- The school has not implemented the planned actions to improve the quality of teaching. There are ongoing weaknesses in this area of the school's work.
- Learning is poorly planned. It is not always clear why pupils are learning what they are learning, how this follows from their previous learning or addresses the gaps in their understanding.
- Teachers' instructions are sometimes confusing. Pupils do not always understand what they are supposed to do and teachers do not tackle their misconceptions effectively. For example, in the Year 3 and 4 class pupils were learning about how to structure an argument. However, the purpose of the learning was lost, as pupils had not fully understood the task.
- In some classes, standards are too low. Some pupils are working below the standards expected for their age and are not set work that will enable them to achieve these standards. In English, Years 5 and 6 pupils do not routinely structure their writing well. They do not use their knowledge of sentence structure to develop their ideas well enough.
- Changes to the teaching staff have left some pupils with significant gaps in their knowledge and understanding. For example, in the Year 1 and 2 class pupils were not able to use their phonic knowledge to decode unfamiliar words. They do not recognise the different sounds that groups of letters can make or blend sounds together well. These pupils have made poor progress in reading, writing and mathematics over the course of this year. However, it is evident that recent changes to the teaching staff have significantly raised expectations for these pupils.
- Some pupils present their work poorly. Teachers do not routinely insist on high



- standards of presentation or ensure that pupils set their work out correctly. In mathematics, this is leading to work that is inaccurate.
- The teaching of mathematics has not improved since the previous inspection. Leaders arranged for training in the teaching of mathematics and, following this training, some improvements were noted. Teachers put in place strategies to ensure that pupils had more opportunities to practise using mathematics in real-life situations. However, these improvements were not sustained. The work that some pupils complete in mathematics is below that expected for their age. For example, pupils in the Year 3 and 4 class have spent time writing out multiplication tables that they have already mastered.
- The standards remain unmet.

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 7(a), 7(b), 11, 12, 13

- The previous inspection found the standards in this part to be met. However, this inspection found failings in the school's work to promote the welfare, health and safety of pupils. The school's safeguarding policy is in keeping with the latest government guidance and is available on the school's website. However, it is not understood well enough by staff, or followed closely.
- Not all staff have been trained in the school's safeguarding procedures. The training that staff have received did not cover the latest government guidance.
- The school has appropriate policies in place to promote pupils' welfare, health and safety. However, leaders and staff do not follow the policies closely enough.
- The school's policy for health and safety details the checks that leaders should make on this aspect of its work. The inspection found that leaders do not follow their own guidance and are not sufficiently alert to health and safety hazards. For example, the policy states that leaders will check the outdoor area for rubbish. The inspection found that the outdoor area contained debris and litter.
- Leaders do not carry out their checks on first-aid equipment frequently. Some out-of-date items were found in the medicine cabinet.
- Leaders have used an external company to check the fire alarm system and the fire extinguishers. However, some aspects of fire safety have been overlooked. During the inspection, some fire doors were propped open, one was blocked with chairs and another did not close properly.

Paragraph 15

■ A high proportion of pupils have left the school during this academic year. Leaders have not checked that these pupils have registered at a new school or made reasonable enquiries to establish their whereabouts. Leaders have not routinely followed the government guidance or the school's policy before deleting pupils from the school's register. They have not always informed the local authority about pupils who have left the school. For example, the local authority did not know about pupils who had left to be educated at home or who had been excluded. In some cases there was a delay of several weeks before the school informed the local authority about pupils who had left. Leaders do not probe the reasons why pupils leave the school or record in sufficient



detail the communication they have had from parents and carers. The lack of oversight of this area puts pupils unnecessarily at risk.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2), 18(2)(c), 18(2)(c)(iv), 18(3) 21(1), 21(3), 21(3)(a), 21(3)(a)(iv)

- The previous inspection found the standards in this part to be met in full.
- Leaders have not carried out all the necessary checks on staff who have joined the school since the previous inspection. They have not checked that staff have the relevant qualifications.
- The single central record does not record that the checks were made.
- All other checks are in place and recorded on the single central record.

Part 5. Premises of and accommodation at schools

Paragraph 25

- The previous inspection found that the proprietor had not ensured that the school site was secure. Not all the locks on the entrances were secure and the grass play area was not safe to play on.
- The entrance doors now have secure locks fitted. The grass play area has been cordoned off so that pupils are not able to play on it.
- However, other health and safety failings were noted during this inspection.
- Leaders do not follow closely all of the school's policies relating to health and safety. Their checks are not frequent or careful enough. A bottle of bleach was found in a classroom that is accessible to pupils. Some parts of the outdoor area contained debris and disused items. Pupils told the inspector that some areas of the school need tidying up, and that they sometimes trip over items left on the floor.
- The standard remains unmet.

Part 8. Quality of leadership in and management of schools

Paragraphs 34, 34(1)(a), 34(1)(b), 34(1)(c)

- The previous inspection found that leaders had not improved the quality of leadership effectively. This remains the case.
- Leaders are not demonstrating the capacity to ensure that all of the independent school standards are met consistently. The standards have not been met in full at any inspection since 2015.
- Following the inspection leaders drew up an action plan that aimed to remedy the weaknesses in teaching. An external consultant delivered training to staff on how to plan learning, and on teaching mathematics.
- Leaders had planned to follow up this training with bespoke development plans for all teachers and with ongoing monitoring of the quality of teaching, learning and

- assessment to ensure that improvements were sustained. Following the decision to close the school, leaders have not implemented all of the planned actions to improve teaching.
- The headteacher in post at the time of the previous inspection left the school at the start of the autumn term. The proprietor is also the principal and has too many responsibilities to be able to carry out all of them effectively.
- There are significant gaps in the school's work to promote the welfare, health and safety of pupils. These gaps leave pupils at risk.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- Leicester International School is an independent Islamic school.
- The school currently provides education for pupils aged five to 11 years but will close in June 2019.
- The headteacher who was in post at the previous monitoring inspection has now left the school.
- The principal is also the proprietor. There are no other leaders in the school. The school does not have a governing body.
- There are no pupils with special educational needs and/or disabilities.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This was the second monitoring inspection following the school's standard inspection on 4 to 6 July 2017. A previous monitoring inspection took place on 16 May 2018. This inspection found that the school was not meeting all of the independent school standards. Following this inspection, the Department for Education required the school to produce a statutory action plan. Ofsted evaluated this plan on 19 December 2018 and deemed it acceptable.
- The inspection was conducted without notice.
- The inspector met with the principal, who is also the proprietor and the designated safeguarding lead. The inspector observed learning in all three classes and looked at a sample of pupils' work in English, mathematics, science and geography. The inspector looked at documentation relating to safeguarding and toured the school site. She spoke with a group of pupils from different classes and with a representative from the local authority.
