# **Summary of key findings for parents**

## This provision is good

- The childminder has established positive partnerships with parents. She regularly shares information regarding children's development and care to help maintain a consistent approach to meeting children's needs.
- Children have formed secure attachments with the childminder. They enjoy interacting with the childminder, gain confidence and have positive self-esteem.
- The childminder helps children to learn about the world around them. For instance, they read about the life cycle of the butterfly, and look at the caterpillars they are caring for, to see if they have grown.
- The childminder supports children to lead a healthy lifestyle. For example, the children enjoy going out in the garden to ride on the scooters to develop their balance and coordination and build their muscle strength.
- Children do not always have a wide range of materials to use to help them to develop their imagination and sensory experiences.
- The childminder does not offer children a wide range of resources to enable them to develop their interest in making marks during daily play activities.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- review and improve the range of experiences children have to explore a variety of sensory resources
- strengthen the opportunities children have to use a range of materials and media to practise making marks as they play.

#### **Inspection activities**

- The inspector checked evidence of suitability of all household members and the childminder's certificates, including her paediatric first-aid certificate.
- The inspector observed the childminder interacting with the children inside and outside and spoke to the childminder and children at appropriate times during the inspection.
- The inspector and childminder observed the children engaged in an activity and the childminder fed back to the inspector about the learning taking place.
- The inspector looked at the children's development folders and discussed with the childminder how she is supporting children and their families.
- The inspector read letters of reference from parents to obtain their views on the service they receive.

# **Inspection findings**

### Effectiveness of leadership and management is good

Safeguarding is effective. The childminder has addressed all actions and recommendations set at her previous inspection. For instance, she has obtained the required suitability checks for all family members living at the home. The childminder closely monitors and supervises the children to make sure she keeps them safe and secure. The childminder has a strong focus on developing her own practice to improve outcomes for children. For instance, she has recently updated her paediatric first-aid certificate and regularly meets up with other early years professionals to share best practice and ideas. The childminder has formed good links with local schools and nurseries to help provide a continuity of care and learning for the children.

## Quality of teaching, learning and assessment is good

The childminder makes effective use of opportunities, to extend children's learning. She encourages conversations as they play and asks skilful questions to help to support children's thinking skills. For instance, they talk about who can park in certain parking bays in the garage and why. The childminder successfully incorporates mathematics into children's play. For example, they look at distance and identify which car has travelled the furthest down the ramp. The childminder carries out regular observations and assessments of the children. She uses her sound knowledge of the children's next steps and interests to enable her to plan a wide range of activities that motivate them to learn. For instance, they enjoy planting and tending to the flowers in the garden, especially the sunflowers. The childminder makes good use of activities to help to support children's speech and increase their vocabulary. For example, she encourages them to name the different fruit as she reads the story and they discuss how they taste.

## Personal development, behaviour and welfare are good

The childminder helps children to learn about the feelings of others. For instance, they talk about being kind to others and take turns to feed the dolls. The children's behaviour is good and they have good manners, such as saying 'please' and 'thank you' to their friends. The childminder efficiently teaches children how to identify and manage risks for themselves. For example, she reminds them to hold on as they climb the slide and to make sure it is clear before going down. They have healthy snacks and are encouraged to have a drink throughout the day to keep hydrated.

## **Outcomes for children are good**

Children gain many skills that they need in preparation for future learning. For instance, they follow good hygiene routines and are learning to attend to their own personal care needs. Children enjoy trips to parks as well as a variety of groups where they interact with friends and develop their personal, social and emotional skills. They make good progress in their learning and development and are ready for the next stage in their lives, such as nursery or school.
