Summary of key findings for parents

This provision is good

- The manager and staff work well as a team and since their last inspection have developed a shared vision and high aspirations for the pre-school.
- Staff are caring, sensitive and responsive to children's needs. There is a wellestablished key-person system in place. This helps children to form secure relationships and promotes their emotional well-being.
- Partnerships with parents, other professionals and schools are good. Staff share information about children's care and learning. This provides effective continuity for children, including children with special educational needs and/or disabilities.
- Parents speak highly of the warm and welcoming staff. They praise the good communication they receive about their children's day and how well they are prepared for school.
- Procedures for self-evaluation do not consistently include the views of staff, children and parents.
- Sometimes, staff miss opportunities to stretch and challenge older children in order to further develop their problem-solving skills.
- Children are not always effectively supported to develop a firm understanding of the expectations for their behaviour.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- develop further the systems for self-evaluation and include the views of staff, children and parents
- extend opportunities within activities to stretch and challenge older children to further develop their problem-solving skills
- support children to fully understand the expectations for their behaviour.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning.
- The inspector spoke with staff and children at appropriate times during the inspection.
- The inspector completed a joint observation of an activity with the pre-school manager.
- The inspector held a meeting with the pre-school manager. She looked at relevant documentation and evidence of the suitability of staff working in the pre-school.
- The inspector spoke to parents during the inspection and took account of their views.

Inspection findings

Effectiveness of leadership and management is good

The arrangements for safeguarding are effective. Staff carefully risk assess the environment and activities. They have a strong understanding of safeguarding procedures and know how to identify a child who may be at risk of harm. They know the action to take to report any concerns. The manager monitors staff performance closely and the deployment of staff is well organised. Staff access ongoing training which ensures they have up-to-date knowledge and skills. The manager reviews children's progress and uses this information to set targets and drive improvements. For example, staff have recently attended training to further support boys' learning and development. Positive relationships are in place with local schools and services relevant to the pre-school. This helps to promote continuity of care and learning.

Quality of teaching, learning and assessment is good

Staff complete regular observations of children as they play. They assess children's learning and development and plan activities to help children to make good progress. Staff are positive and support children to develop their communication and language skills well. They engage children in conversations about their interests and experiences. Staff use a range of strategies, such as providing children with a running commentary during play, repeating words so younger children can hear the correct pronunciation and introducing new words to extend older children's vocabulary. Children are engaged and motivated to learn. They enjoy dressing up and develop their imagination as they pretend to be fairies and turn staff into frogs.

Personal development, behaviour and welfare are good

Children move around the room, choosing what to play with from the wide range of resources available. They enjoy their time outside and develop their physical skills and the ability to manage their own safety. For example, children hammer nails into wooden planks and delight in weaving coloured ribbon in and out of the nails. Children learn about the importance of leading a healthy lifestyle. They are provided with healthy snacks, such as cereals and fruit. Children wash their hands and pour milk into their own bowls as they develop independence and self-care skills. Children brush their teeth daily. This helps to support their understanding of oral health and hygiene.

Outcomes for children are good

Children are engaged and motivated to learn. They enjoy directing their own play and choosing their own activities. Children have plenty of opportunities to practise their early writing skills. For example, children make marks in coloured sand and write their name on a list before riding on the scooters and bikes outside. Children's mathematical skills are promoted throughout the setting. They explore different concepts and use language to explore size, shape, numbers and measurement. Children make good progress in their learning and are developing the skills they need for future learning. They are well prepared for the move onto school. Children demonstrate good social skills and are very self-assured.

Little Stars Pre-School registered in 2016. The pre-school employs six members of childcare staff, all of whom hold appropriate early years qualifications at level 2 or above. The pre-school opens from Monday to Friday during term time only. Sessions are from 9am until midday. The pre-school provides funded early education for two- and three-year-old children.
