Summary of key findings for parents

This provision is inadequate

- Safeguarding practices are weak. The management team do not take prompt action to update the appropriate agency in line with the Local Safeguarding Children Board (LSCB) about significant changes in children's circumstances and concerns about their welfare. Similar child protection breaches have been recently made and the appropriate managers have not taken sufficient action to make the required improvements. This significantly compromises the overall safety and welfare of children.
- The management team do not ensure essential records are made available for inspection. This means children's safety cannot be assured.
- The quality of teaching is inconsistent. Not all staff have the skills and expertise to ensure that all children across all age groups have consistently engaging and challenging learning experiences. This means that some children lose interest and wander around on occasions. Not all children make the best possible progress from their starting points.
- Self-evaluation is not effective in promptly addressing key weaknesses in staff practice and the overall quality of the provision.

It has the following strengths

- Most children seem to enjoy their time at the nursery. Younger babies and older children generally have interesting opportunities to learn and show interest in their environment.
- Most parents express they are satisfied and happy with the provision. This is illustrated when they express their children are making progress and they find staff friendly and approachable.

What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action:

Inspection activities

- The inspector observed the quality of teaching and assessed the impact this has on children's learning.
- The inspector completed several joint observations with the manager.
- The inspector spoke to a number of parents and took account of their views.
- The inspector looked at a range of documentation, including evidence of staff training and children's assessment records.
- The inspection was carried out following concerns in relation to the quality of interactions of some staff members and how this has an impact on children's daily experiences.

Inspection findings

Effectiveness of leadership and management is inadequate

Safeguarding is ineffective. The management team has failed to address breaches in the safeguarding and welfare requirements, for instance to ensure that all staff have a secure knowledge and understanding of their roles and responsibilities to keep children safe, with particular regard to the 'Prevent' duty and if an allegation is made against a member of staff. Leaders and managers do not promptly report any significant changes that may affect children's well-being and do not make essential records available for inspection. Although there is some commitment to ongoing professional development, and the manager holds regular supervision meetings to support staff's personal effectiveness, this has not been successful in ensuring that all staff consistently teach to a good standard. A new quality improvement manager has recently been employed and there are plans in place to work towards addressing the weaknesses in the provision.

Quality of teaching, learning and assessment requires improvement

The quality of staff's teaching and their interactions with children is variable. Some staff, especially those working with the two to three-year-olds, are not always alert to times when children need support to extend their learning. On occasions, this leads to children becoming disengaged because staff miss opportunities to motivate and stimulate them. Staff observe children to identify what they need to learn next and plan a range of activities. However, some staff are more skilled than others in promoting children's learning and development. Despite this, most older children's learning is appropriately guided. This is illustrated when staff question them during story time and use visual props to reinforce their understanding and knowledge. Staff working with younger babies encourage them to learn new words and enjoy counting numbers effectively. For instance, they model language and encourage children to repeat new vocabulary when exploring animals in the sand and playing with a variety of puzzles.

Personal development, behaviour and welfare are inadequate

Significant weaknesses in leadership and management comprise children's safety. The management team does not give sufficient priority to children's welfare needs. Nevertheless, most children seem content and enjoy attending. They build good relationships with each other and display developing social skills. Older children enjoy playing collaboratively together and developing their imagination. Most staff frequently give children praise and encourage them to learn new skills. Children have frequent opportunities to learn about their local community and the wider world. This is evident when they go on trips to the fire station and when parents come in to discuss their occupations.

Outcomes for children require improvement

Overall, most children make steady progress in relation to their starting points. However, because some children's individual learning needs are not met, they are not always fully ready for their next stage of learning, including school. Staff identify when children need extra support with their learning. However, due to the inconsistencies in teaching, some children, especially those with special educational needs and/or disabilities and those who speak English as an additional language, do not make the full progress they are

capable of.
