# Information about this children's home

A local authority manages this secure children's home. It is approved by the Department for Education to restrict young people's liberty. The children's home can accommodate up to 15 children and young people who are aged between 10 and 17 years. It provides for children and young people accommodated under section 25 of the Children Act 1989 who are placed by local authorities. Admission of any child under section 25 of the Children Act 1989 who is under 13 years of age requires the approval of the Secretary of State. Education is provided on-site in dedicated facilities.

The manager has been registered since 2011.

## This inspection

#### The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

The manager has met the requirement and two recommendations raised at the last interim inspection. This demonstrates the capacity to improve.

The manager has reviewed and updated the location risk assessment to include all potential risks in the locality. The use of ligature cutters to keep the children safe has not been necessary. However, staff have now received training in this area.



Building work has been finalised to provide two additional en suite bedrooms with communal areas. These are used for children who require high-dependency support or are moving on. A new, welcoming and light library area that is accessible to all children has prompted a significant increase in children's reading.

Children live in a well-maintained home that they respect and care for. The staff carefully maintain equipment and resources. Damage is repaired without delay. The children personalise their rooms, and the communal living areas are welcoming. This results in a comfortable and relaxing home in which children can progress and thrive.

Children spoke with overwhelming enthusiasm about the nurturing care that they receive. They develop warm relationships. They know the staff well and they feel listened to. Staff are efficient in meeting, and responding to, children's needs. As a result, the children feel valued and respected.

The staff have an in-depth understanding of the children's backgrounds. They consistently deliver care and implement strategies that focus on identifying and meeting children's individual needs. Therefore, children make good progress in all areas of their development. The children spoke passionately about how the staff spend quality time with them. Staff support them to understand the reasons for the placement and the changes that they can make to keep themselves safe. This approach gives children hope and aspiration for a positive future.

Staff motivate children to engage in individual programme sessions, which are focused appropriately on their identified needs. Children embrace their hobbies and interests, using the gym, the music room and hair and beauty facilities. This supports children to make positive choices about using their time and to continue with these new interests when they leave the home.

Staff understand how important children's families are to them. The staff work with families and placing authorities to facilitate family visits. These interactions help children to maintain important relationships and ensure that they are not isolated from their families.

The staff are alert to any changes in children's behaviours. Individual behaviour management plans, risk assessments and multi-disciplinary meetings enable children to manage their behaviour. Over time, the number of incidents reduces. Children spoke about how the staff have helped them to see that what they were doing before was placing themselves at risk. One child spoke about how angry he was before and how he now has strategies to help regulate his behaviour.

Children receive support from a highly motivated, enthusiastic staff team that has a child-centred approach. This is because staff feel well supported and valued in their roles. Monthly reflection meetings with the on-site healthcare team provide the staff with an opportunity to discuss any concerns and to manage their own emotions that have arisen from incidents.



Physical interventions are appropriate to keep children and staff safe. However, the manager does not consistently identify learning and required improvements to records. The records of physical interventions lack detail of the incident. Therefore, staff continue to make errors in recording, which makes it difficult to monitor physical interventions effectively.

Two previous recommendations relating to the education provision were not assessed at this inspection and will be reviewed at the next full inspection.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.
