Summary of key findings for parents

This provision meets requirements

- The provider has taken positive steps, such as collaborating with the school and other professionals, to ensure actions set at the previous inspection are met. For example, he has a system to share the club's menu with the parents and ensures recruitment procedures are robust and effective.
- The provider has a secure knowledge of his responsibility to ensure all staff know the child protection procedures and how to refer concerns to the relevant agencies. The provider ensures that the learning environment for children is safe and suitable. He is able to demonstrate how he will use risk assessments to help him achieve this.
- The provider has a good understanding of how to contribute towards promoting children's healthy lifestyles. For instance, through healthy diet, good hygiene procedures and exercise.
- The provider has a secure knowledge of the importance of providing children with challenging activities and resources, taking their abilities and interests into account when planning.
- The provider demonstrates some capacity to continually improve practice. He seeks feedback from children, parents, staff and other professionals to support evaluation procedures and drive improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and the provider looked at the areas and resources available for children's use.
- The inspector discussed with the provider his understanding of the requirements of the early years foundation stage and of other government requirements, and how he intends to meet these when children attend in the future.
- The inspector discussed with the provider how he intends to deliver the educational programmes for children, ensuring activities and resources are challenging and stimulating.
- The inspector discussed and reviewed the policies and procedures that the provider will use, including the child protection policy.
