Overall outcome

The school is likely to meet the relevant independent school standards if the material change relating to the school provision is implemented

Main inspection findings

Part 1. Quality of education provided

Paragraphs 2, 3, 4, 5 and 34

- Leaders wish to extend the school's age range from 5 to 11 to 5 to 12 to allow a very few existing pupils to remain in the school, in order to benefit from the therapeutic education being provided.
- The school's curriculum and assessment policy and related programmes of study have been suitably extended to account for pupils in Year 7.
- Planning covers all the required areas of learning, and takes account of pupils' interests and special educational needs and/or disabilities (SEND).
- The planned curriculum includes detailed coverage of English, mathematics, science, the creative arts (art, design and technology, music and dance), humanities, physical education and healthy living, and computing.
- The curriculum also includes a comprehensive approach to developing pupils spiritually, morally, socially and culturally. Weekly personal, social, health and economic education lessons, and assemblies and a range of trips are likely to provide pupils in Year 7 with ample opportunities to learn about British values and equality.
- Leaders have also made suitable arrangements to ensure that pupils in Year 7 access regular, impartial and high-quality careers information, advice and guidance.
- Leaders have worked effectively to ensure the relevant independent school standards listed above are likely to continue to be met if the material change is implemented.

- The school makes no use of alternative provision.
- The school's child protection policy reflects the latest statutory guidance, and is published online.



Information about this inspection

- The inspection was commissioned by the Department for Education (DfE) to consider the school's application to make a material change to its registration agreement. The proposed change is to increase the age range of pupils from 5–11 to 5–12.
- The DfE requested that the inspector consider whether particular independent school standards contained within Parts 1, 2 and 8 are likely to be met if the material change is implemented.
- The inspector conducted the inspection remotely. He considered the school's proposed curriculum documentation and had two telephone conversations with the headteacher. He discussed the reasons for the material change request and the proposed curriculum for pupils aged 12.
- There were not enough recent responses to Ofsted's online survey (Parent View) to consider as part of this inspection.
