This provision meets requirements

- The childminder holds a current certificate in paediatric first aid. She demonstrates sound knowledge of how to deal with accidents and injuries.
- The childminder knows how to evaluate her provision and identify precise targets for development to improve outcomes for children. She uses training to continually update her knowledge and skills.
- The childminder is knowledgeable about safeguarding issues and regularly updates her training. She knows how to deal with possible safeguarding concerns to protect children's welfare.
- The childminder understands the importance of working in partnership with parents and other professionals to provide consistent support for all children.
- The childminder demonstrates a secure understanding of the learning and development requirements. She intends to monitor children's progress and identify and address any gaps in their learning to help them to progress.
- The childminder knows how to support children's understanding of healthy lifestyles, including the benefits of physical exercise and eating healthy foods.
- The childminder is passionate about providing an inclusive service where all children feel valued and welcome.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector had a tour of the areas of the childminder's home intended to be used for childminding purposes. She viewed the toys and resources available.

- The inspector verified evidence of the childminder's suitability and training and checked evidence of the suitability of adults living on the premises.
- The inspector discussed with the childminder her knowledge and skills related to the learning and development requirements.
