## Summary of key findings for parents

#### This provision meets requirements

- The childminder understands the importance of evaluating her provision to identify and target professional development needs. She completes regular training to enhance her teaching skills and to keep up to date with safeguarding matters. The childminder's knowledge of the procedures to follow if she is concerned about any aspect of a child's welfare is secure.
- The childminder understands the requirements for completing assessments on children and for using the information she gains from these to plan for their progress.
- The childminder has a wide range of play and learning resources and equipment suitable for children from birth to under eight years.
- The childminder recognises the benefits of working in partnership with parents and others involved with children to ensure they receive consistent support. Parents say they are very well informed about children's progress and ways to extend their learning at home.
- The childminder understands the importance of promoting healthy lifestyle habits. She describes how she teaches children about nutrition and promotes physical exercise and daily opportunities for children to play and learn outdoors.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### **Inspection activities**

- The inspector checked evidence of the childminder's qualifications and suitability.
- The inspector checked the suitability of the premises, furniture and equipment and assessed the childminder's understanding of providing appropriate resources for children's different stages of development.
- The inspector spoke to the childminder about how she supports children's learning and development and meets the safeguarding and welfare requirements.
- The inspector looked at relevant policies and documents that the childminder uses.

The childminder registered in 2007 and lives in West Molesey. She operates Monday to Friday between 7.30am and 6.30pm throughout the year. The childminder holds a childcare qualification at level 3.
