Summary of key findings for parents

This provision meets requirements

- The childminder understands the importance of evaluating her provision, and planning and implementing further improvements. She keeps her knowledge and skills up to date. She demonstrates this by networking with other childminders and attending local authority cluster meetings.
- The childminder has a good understanding of how to promote children's learning and development. She knows how to adapt her approach to meet the needs of individual children, including those who have special educational needs and/or disabilities.
- The childminder understands the importance of working in partnership with parents. She recognises the benefits of sharing information with parents to help provide a consistent approach to children's care and learning.
- The childminder understands how to help children lead a healthy lifestyle, such as by spending time outdoors and being active. She describes how she promotes positive behaviour and supports children's emotional well-being.
- The childminder has a good understanding of safeguarding and wider child protection issues. She demonstrates a secure knowledge of the correct local reporting procedures to refer concerns about children's welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed parts of the childminder's home that she uses when caring for children.
- The inspector discussed with the childminder how she delivers the learning and development requirements of the early years foundation stage when children are present.
- The inspector sampled documentation, including the childminder's qualifications, evidence of her suitability and policies and procedures she uses when caring for children.
- The inspector spoke to the childminder about her understanding of safeguarding and child protection.

The childminder registered in 2011. She lives in Wendover, in Buckinghamshire. She operates Monday to Friday from 7.30am until 6.30pm all year round. The childminder holds a foundation degree in early years childcare and education. She accepts funding for the provision of free early education for children aged two, three and four years.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
