Summary of key findings for parents

This provision meets requirements

- The childminder would support children's understanding of a healthy lifestyle. She intends to give them an opportunity to try a variety of different fruit and vegetables and would prepare them in fun ways, such as a banana presented as a dolphin.
- The childminder plans to reflect regularly on her practice and intends to seek the views of children and parents to help improve the quality of her setting.
- The childminder recognises the importance of keeping up to date with new guidelines and requirements. For example, she has updated her safeguarding knowledge to include new guidance to help keep children safe.
- The childminder understands how children learn and intends to plan activities to keep them motivated and interested in learning. She intends to put together a development plan to help each child progress.
- The childminder knows how to teach children about keeping safe and to be aware of their own personal risk and safety. For example, she plans to teach them how to risk assess equipment themselves and to learn how to cross a road safely.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the premises used for childminding.
- The inspector and childminder discussed her knowledge of safeguarding, risk assessment, child development and self-evaluation.
- The inspector reviewed the resources and talked to the childminder about how she would plan activities to support children's learning.
- The inspector sampled documentation, including planning, policies and procedures.
