

## **Compliance action taken for childcare provision**

### **Summary of outcome**

All early years providers must meet the legal requirements in the 'Statutory framework for the early years foundation stage', which you can find at [www.gov.uk/government/publications/early-years-foundation-stage-framework--2](http://www.gov.uk/government/publications/early-years-foundation-stage-framework--2). If we find that a provider is not meeting the requirements, we can take action to ensure they put matters right. On 6 June 2019 we received concerns that this provider was not meeting some of these requirements. We visited the provider and found they were not meeting legal requirements. We have served a Welfare Requirements Notice. This is a legal notice that requires the provider to take the actions below within the timescales set out. We also raised a notice to improve which requires the provider to take action by the timescales set out. The provider will be able to give parents further information about this. The provider is still registered with Ofsted.

#### **Welfare Requirements Notice actions:**

ensure procedures for checking the safety of the equipment and environment are effectively implemented to keep children safe, with particular regard to the gate to the outdoor play area - due by 26/9/19

ensure effective systems are in place to make sure that all staff who have regular contact with children are suitable to fulfil the requirements of their role - due by 26/9/19

ensure that all staff receive induction training to help them understand their roles and responsibilities - due by 26/9/19

ensure all staff have an up to date knowledge of safeguarding policies and procedures and ensure they implement the mobile phone and camera policy - due by 26/9/19

ensure confidentiality is maintained and staff and children's details are held securely - due by 26/9/19

ensure you keep an accurate daily record of the names of the children being cared for on the premises, their hours of attendance and the names of each child's key person - due by 26/9/19

ensure children receive healthy balanced and nutritious food and snacks - due by 26/9/19

ensure premises are organised to meet the needs of the children so that there is a good range of toys and play equipment accessible to the children - due by 26/9/19

Notice to improve actions:

plan a challenging and enjoyable experience for each child in all of the areas of learning and development - due by 26/9/19

### **Publication of compliance action**

We aim to ensure that the welfare of children and young people is protected in the services we regulate. The Childcare Act 2006 and accompanying regulations set out our responsibilities to regulate childminders and childcare providers. This includes the enforcement powers we have in relation to those registered providers who do not comply with the requirements for registration.

We publish details of any actions we take, or the childminder or childcare provider takes to bring about compliance with requirements on our website for a period of five years

commencing on the date we complete our investigation.
