Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

The service specialises in providing care for children who have suffered early life trauma. There is an acting manager in post who is not yet registered with Ofsted.

Inspection date: 22 July 2019

This monitoring visit

Following the inadequate judgement in April 2019, Ofsted carried out a monitoring inspection of the home. This was to monitor the progress in meeting the two compliance notices and eight requirements. The visit found that there were ongoing concerns. As a result, not all of the requirements were met, and a compliance notice was reissued. This was aimed at helping staff to drive improvement.

During this visit, further serious safeguarding concerns were identified. This shows that there are serious and continued safeguarding concerns that the new management team has failed to address.

Despite the home having been re-issued a compliance notice setting out the necessary actions required in regard to the young person's risk assessments, shortfalls remain. For example, not all risk assessments could be found during the inspection. This failure to locate essential documents means that staff do not have easy access to all the necessary information they need to enable them to protect the young person from harm.

Managers have failed to understand their role in the protection of children. For example, the young person alleged that he had been hurt by a member of staff. Despite managers being made aware of this raised concern by the young person, managers failed to implement the organisation's safeguarding procedures to ensure that the information was shared with the local designated officer. This failure to report means that there has been no external scrutiny of staff practice. This referral was only triggered once the inspector had raised this with the manager.

The manager's and staff's understanding of physical restraint practice is weak. The



inspector found that the manager was not able to identify when a member of staff's response to an incident had become a physical intervention. Another physical restraint reviewed by the inspector was discussed with the responsible individual who deemed this physical restraint to have involved unnecessary force.

Despite managers ensuring that the fire risk assessment is now up to date, not enough has been done to ensure that all staff have read this new version. This leaves some staff still unclear of the steps needed to safeguard everyone in the home from the risk of fire. This is a further missed opportunity to demonstrate the manager's capacity to carry out his role in safeguarding the young person, staff and visitors to the home.

Staff fail to ensure that they sign the young person's medication chart at the time they administer the medication. This omission means that anyone viewing the chart is unsure whether the young person has received his medication for the management of his epilepsy.

Despite previous raised concerns over the new management team requiring an induction to the home, this has still not taken place. The plan is for the manager to have an induction carried out by the responsible individual. This is despite the responsible individual also still waiting for his own induction. This demonstrates the lack of support and guidance to new managers to ensure that they receive the help that they need to perform their roles in the organisation.

Staff have now received training that is helping to improve their practice. However, overall, improvements have not been sustained and the necessary improvements remain far too slow. This has led to the ongoing failure of staff to protect the young person they have in their care.

The restriction of accommodation notice remains in place. Ofsted will continue to closely monitor the service.

Statutory requirements

The registered person must make arrangements for the handling, recording, safekeeping, safe administration and disposal of medicines received into the children's home.	16/08/2019

The registered person must ensure that within 24 hours of the use of a measure of control, discipline or restraint in relation to a child in the home, a record is made which includes the name of the child; details of the child's behaviour leading to the use of the measure; the date, time and location of the use of the measure; a description of the measure and its duration; details of any methods used or steps taken to avoid the need to use the measure; the name of the person who used the measure ("the user"), and of any other person present when the measure was used; the effectiveness and any consequences of the use of the measure; and a description of any injury to the child or any other person, and any medical treatment administered, as a result of the measure; within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person") has spoken to the user about the measure; and has signed the record to confirm it is accurate; and within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the measure. (Regulation 35(1)(a)(b)(3)(a)(i)(ii)(iii)(iv)(v)(vi)(vii)(viii)(b)(i)(ii)(c))
