Summary of key findings for parents

This provision meets requirements

- The childminder explains how she will work in partnership with parents to support children's ongoing learning and development. She identifies the importance of building continuity of care between home and the setting.
- The childminder has a secure knowledge of safeguarding procedures. She is able to recognise signs of potential abuse and knows how to escalate concerns about the welfare of a child.
- The childminder has a good understanding of the early years foundation stage requirements and knows how to plan appropriate activities to enhance children's learning opportunities.
- The childminder discusses how she aims to promote healthy lifestyles, such as involving children in preparing meals and learning about healthy choices. She provides an engaging range of outdoor resources to enhance their physical development.
- The childminder explains how she intends to include the views of parents and a childminding support network to evaluate her provision and implement strategies to continually improve practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and the childminder discussed the childminder's knowledge of the early years foundation stage.
- The inspector looked around the premises to check the suitability of the resources and environment.
- The inspector sampled a range of documentation, including training certificates and parents' evaluations.

The childminder registered in 2005 and she lives in Chadwell Heath, in the London Borough of Redbridge. She operates during term time from 7.30am to 6pm, Monday to Friday.
