Summary of key findings for parents

This provision is outstanding

- The childminder exudes enthusiasm and displays an absolute passion for her role as a childminder that children cannot help but respond to. Children have tremendous fun as they learn and delight in joining in with activities. They are exceedingly confident and self-assured learners.
- The childminder is highly sensitive to children's needs. She intuitively knows when to stand back and observe and when to skilfully intervene to support children's learning. Children show they feel extremely safe and secure in the childminder's presence.
- The childminder makes full use of her qualifications and excellent knowledge of how children learn. She monitors children's progress precisely and uses her accurate assessments to identify what children can do. The childminder precisely targets the next steps in children's learning.
- The childminder works very closely with parents to gather high-quality information about children's current development before children start with her. She uses this information extremely effectively to plan activities that interest children and give meaningful support to their learning from the start.
- The childminder places an exceptionally strong emphasis on her professional development. She is proactive in identifying meaningful training to enhance opportunities and outcomes for children.
- Partnerships with other settings children also attend are exceptional. For instance, the childminder and practitioners from the other settings work together to write transition documents for children who are moving on to school.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

continue to explore professional development opportunities to sustain excellence in practice and teaching skills.

- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning and development.
- The inspector spoke with the childminder and children throughout the inspection.
- The inspector completed a joint observation with the childminder.
- The inspector looked at relevant documentation and evidence of the suitability of all adults living in the household.
- The inspector took account of the written views of parents.

Inspection findings

Effectiveness of leadership and management is outstanding

The childminder strives for excellence and meticulously evaluates her provision. She carefully considers improvements and understands the importance of incorporating children's and parents' views when doing so. The childminder is diligent in ensuring parents remain up to date about their children's ongoing care and the progress they are making. Safeguarding is effective. Children's safety is of the utmost importance to the childminder. She has an excellent knowledge and understanding of child protection, including any signs that would give cause for concern. The childminder is clear about the procedures for reporting concerns. She has close relationships with a network of other childminders. They meet regularly to share information and ideas to enhance practice.

Quality of teaching, learning and assessment is outstanding

The childminder is an especially skilled practitioner. She is extremely able to transform a simple activity, such as water play, into a wealth of learning. For instance, she shows young children how to hold a sponge so water flows out of it. Young children readily try this themselves and discover they can capture the flowing water in beakers. The childminder interacts exceptionally well with children and surrounds children in a language-rich environment. She sits with children to promote conversation, skilfully using open-ended questions to encourage children to think. The childminder uses spontaneous events to foster children's listening skills. For instance, children hear the sounds of an aeroplane and the childminder encourages them to be quiet and to listen to the silence once the noise has passed.

Personal development, behaviour and welfare are outstanding

The childminder supports children's emotional well-being brilliantly. Children are happy, confident and behave exceptionally well. Young children show high levels of determination in their abilities to solve problems for themselves. Children have a joyful time learning with the childminder. For instance, before eating, they happily sing to the movements they are making as they wash their hands. This creates an enjoyable experience for children to learn about how to keep themselves healthy. The childminder is very genuine in her praise and enthusiastically celebrates children's achievements. The childminder provides many varied and interesting opportunities for children to socialise and learn about their local community and the wider world.

Outcomes for children are outstanding

All children are making exceptionally good progress and are developing the skills needed for future learning. They have many opportunities to develop their mark-making skills at the different groups they attend and are proud to show the pictures they have created. Children become totally absorbed in their learning and remain engrossed in their chosen play for long periods of time relative to their age.
