## Summary of key findings for parents

### This provision meets requirements

- The childminder recognises the importance of meeting the individual care and educational needs of all the children she cares for. She explains that her role working in close partnership with associated professionals will support children's well-being and help them make progress in their learning.
- The childminder values a close working relationship with parents. She recognises the benefits of two-way, direct communication with home to provide children with continuous care routines and ongoing learning opportunities.
- The childminder describes how she will gather initial and ongoing information about children from parents and others involved in their care. She talks about how she develops activities based on children's interests and needs.
- The childminder demonstrates a clear understanding of her role and responsibility to safeguard children. She describes the procedure she will follow if she has a concern about a child's welfare. She understands how to recognise if a child is at possible risk of being exposed to extreme ideas or behaviours, and the correct course of action to keep them safe.
- The childminder is warm and welcoming. She describes how she intends to provide an inclusive setting where children are treated equally and their ideas are valued.
- The childminder builds links with advisers and other practitioners. She shares how she seeks the opinions of parents and children to help develop her service and drive forward improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## **Inspection activities**

- The inspector held a meeting with the childminder. She looked at relevant documentation, including the setting's risk assessments and evidence of the childminder's suitability.
- The inspector read the testimonials of a variety of past and present parents during the inspection and took account of their views.
- The inspector discussed with the childminder how she delivers the educational programmes for children and undertakes observation, assessment and planning.
- The inspector viewed the areas of the childminder's home used by children and discussed the equipment and toys available.
- The inspector sampled relevant documentation.
- The inspector discussed the safeguarding and welfare requirements with the childminder, including the risks of radicalisation and extremism.

The childminder registered in 2003 and lives in the London Borough of Wandsworth. She operates from Monday to Friday all year round, except for bank holidays and Christmas.
