Summary of key findings for parents

This provision is good

- Parents speak positively about the camp. They are complimentary about the care and support their children receive. They say their children enjoy attending and that staff keep them well informed about their children's activities.
- Children have positive relationships with each other and staff. They demonstrate a strong sense of teamwork as they play games together and help each other to complete tasks.
- Children are encouraged by staff to be physically active. Staff use their expert knowledge to engage children in exciting activities, such as volleyball and other team games.
- Leaders and staff ensure that the premises are safe and children receive good levels of supervision to help reduce the risk of incidents and accidents.
- Children behave well. Staff are positive role models who speak respectfully to children and model the use of good manners. Children are polite, sociable and learn to share and take turns.
- Staff do not provide a wide variety of resources and activities to help engage younger children who prefer to play outside.
- Staff do not make the most of opportunities to share information with parents and children about healthy eating, particularly the effects certain foods and drinks can have on children's health.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- build on the good range of experiences offered at the camp, to further engage younger children who prefer to learn outside
- enhance partnership working with parents even further, to share more information about healthy eating, with particular regard to the effects of this on children's health.

Inspection activities

- The inspector viewed all areas of the setting accessed by children and observed children engaging in activities indoors.
- The inspector completed a joint evaluation of an activity with the provider.
- The inspector took into account the views of staff, parents and children spoken to on the day of the inspection.
- The inspector checked evidence of the suitability and qualifications of staff working with children, and discussed the provider's self-evaluation.
- The inspector spoke to the provider, manager and members of staff at appropriate times during the inspection.

Inspection findings

Effectiveness of leadership and management is good

Safeguarding is effective. The provider and staff are vigilant and have a good understanding of how to deal with any child protection concerns. Rigorous recruitment and ongoing suitability checks are in place to ensure staff are suitable to work with children. The provider has regular meetings with staff to give feedback and offer further support and guidance. Staff work together to implement the daily routines, policies and procedures effectively. The provider accurately evaluates the effectiveness of the camp and supports staff well to continue to develop their practice. For example, they have completed training in order to provide more stimulating activities in arts and crafts. The provider takes into account the views of staff, parents and children to help identify priorities for improvement.

Quality of teaching, learning and assessment is good

Children enjoy challenges, such as designing and creating their own masks from a variety of materials. They take great delight in showing the finished models and display them proudly. Children concentrate well on tasks, for example as they enthusiastically invent their own types of fish from a variety of materials. They enjoy the activities available to them. For example, children play games together in small groups and teams, taking turns and following the rules. Staff encourage children's confidence and give them opportunities to make choices. They interact with children effectively during their play and encourage them to talk about their experiences to support their communication and language skills well. Staff support and encourage children to share their views and contribute to discussions. For example, children consider the camp rules and understand why they are important.

Personal development, behaviour and welfare are good

Staff encourage children to be independent and take responsibility for their own belongings. For example, when they arrive, they hang up their own coats and bags. Children collect their own snacks and tidy away after themselves. When children arrive, they are eager to come in and engage quickly with the activities that staff have set up for them. Staff encourage children to participate actively in physical team games, such as football. They embed good hygiene routines into the session. For example, children wash their hands before having their snack and lunch. Staff promote children's welfare effectively. For instance, they gather information from parents about children's medical needs before they attend the camp so that they know children's individual requirements. Children have close relationships with staff and enjoy their interactions with them.
