This provision meets requirements

- Staff demonstrate a very good understanding of how children learn and develop. They recognise the importance of planning activities based on their existing interests, in order to promote their enjoyment and learning.
- The provider and staff are particularly clear on the need to work closely with parents, schools and outside agencies, to provide individual support for all children with special educational needs and/or disabilities (SEND).
- The provider and staff demonstrate a very good understanding of the signs and symptoms of abuse and how to report concerns regarding children's welfare. As a result, they demonstrate the ability to protect children from harm.
- The provider has devised effective systems to promote professional development. Staff benefit from regular supervision and frequent opportunities for training, in order to enhance their existing skills and knowledge.
- The provider demonstrates a commitment to continually improve the setting. They have effective procedures to obtain the views of staff, parents and children, in order to identify priorities for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the available premises and equipment both indoors and outdoors.
- The inspector spoke with the provider to ascertain their understanding of the requirements of the early years foundation stage.

White Lodge Centre Playscheme, known as 'Twinks', registered in 2009. It is one of four specialist playschemes and a nursery run by the White Lodge Centre. The playscheme caters solely for children with SEND. The premises are located on the outskirts of Chertsey and Lyne in Surrey. Access to the playscheme is through a social care referral. The playscheme operates on Tuesday to Friday during the school holidays, between 10am and 4pm. Eight staff are employed. The manager has a degree in early years. The playscheme is able to take a maximum of eight children at any one time due to funding.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
