Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a), 7(b)

- Leaders' actions to keep pupils safe are effective. Staff have had the relevant training to allow them to fulfil their safeguarding responsibilities. The school's safeguarding policy is available on the school's website and follows guidance issued by the Secretary of State for Education. Leaders have clear processes in place, so staff know what to do when they have concerns about pupils' welfare. Staff record these concerns well and form chronologies, which leaders use to evaluate the most appropriate action. Leaders are currently evaluating the method for recording these concerns, including moving over to electronic methods. Currently, leaders are working out of several folders, including some that are archived. This makes the process of evaluating trends over time more difficult. However, it does not compromise the effectiveness of safeguarding at the school.
- The standard in this paragraph is now met.

Paragraph 16, 16(a), 16(b)

- Risk assessments are poor in quality. Despite this being an unmet standard at the previous monitoring inspection, leaders have not made the necessary improvements. Risk assessments for off-site activities are particularly poor. Staff have copied and pasted from existing risk assessments when recording risks and the actions they will take to reduce these occurring. Apart from the information at the top of each risk assessment, which names where pupils are going, all risk assessments are identical to one another. This process lacks rigour, inhibits how well staff reduce risks and puts pupils at unnecessary risk of harm.
- The standard in this paragraph remains unmet.
- Leaders have not ensured that the overall standard in this part is met.



Part 4. Suitability of staff, supply staff, and proprietors

Paragraph 18, 20

- The proprietor has successfully checked whether school leaders are subject to a direction under section 128 of the Education Act 2008, which prohibits them from taking part in the management of an independent school.
- At the time of the inspection, leaders had not checked that all staff employed to teach at the school were not prohibited from teaching. However, leaders successfully rectified this during the inspection.
- Despite the need to rectify this aspect of leaders' work, the standard in this paragraph is now met.

Paragraph 21

- Leaders have ensured that the school's single central register is maintained in line with statutory guidance. However, changes were made during the inspection to ensure necessary compliance. Leaders use a range of methods for recording recruitment checks. This unnecessarily complicates the process and risks lack of compliance in the future. Leaders acknowledge the need to strengthen how well they ensure the school's single central register meets the independent school standards.
- Despite changes needed during the inspection, the standard in this paragraph is now met.
- Leaders have ensured that the overall standard in this part is met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1)(a–c)

- Leaders' knowledge of the independent school standards is not sufficient to ensure that these are consistently met. At the previous monitoring inspection, several standards were unmet. A number of these remain unmet. In addition, the lead inspector allowed leaders to make an additional check on recruitment during the inspection as this had not been completed. This raises questions about how well leaders know how best to ensure that the independent school standards are met in full.
- Leaders have started to undertake work with an external consultant to help them with this aspect of their work. The proprietors recognise the need to ensure that there is expertise at leadership level, so they are not too reliant on this external support. Leaders at the school are developing an understanding of the independent school standards but, as yet, this is not sufficiently in depth.
- Leaders cannot ensure pupils' well-being is actively promoted as the quality of risk assessments is poor and does not effectively recognise risks to pupils.
- The standard in this part remains unmet.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- Since the previous monitoring inspection, the school name has changed from Willows to Fusion College. In addition, the body of proprietors has changed to Fusion College Ltd.
- Fusion College is an independent special day school. The school was established in 2005. It moved to its current site in 2007.
- The school offers provision for up to 16 girls who have severe social, emotional and behavioural difficulties.



- Pupils are placed by their respective local authority.
- The proprietor has responsibility for the governance of the school.
- The school does not use any alternative provision.
- The school's previous standard inspection took place on 16–18 January 2018, when it was judged to be inadequate and a number of independent school standards were not met. Following this, a progress monitoring inspection took place in September 2018 when several independent school standards remained unmet.
- The school complies with its registration agreement.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- The inspection was the second progress monitoring inspection since the previous standard inspection and was carried out without notice.
- The previous monitoring inspection in September 2018 judged several independent school standards to remain unmet. The school was required to produce an action plan explaining how it would meet the independent school standards that were unmet at this inspection. This action plan, evaluated on 28 December 2018, was judged as being acceptable with modifications.
- The lead inspector met with the headteacher and the registered manager to discuss actions taken since the previous monitoring inspection to meet unmet independent school standards. The lead inspector evaluated the school's single central register and several staff personnel files to determine whether leaders had completed the required recruitment checks on staff.
- The lead inspector scrutinised the quality of risk assessments for both on- and off-site activities. The lead inspector also held a safeguarding meeting with the headteacher to determine how well staff identify concerns about pupils' welfare and how diligently leaders act to involve external agencies.
