

Compliance action taken for childcare provision

Summary of outcome

All early years providers must meet the legal requirements in the 'Statutory framework for the early years foundation stage', which you can find at www.gov.uk/government/publications/early-years-foundation-stage-framework--2. If we find that a provider is not meeting the requirements, we can take action to ensure they put matters right.

On 22 March 2019, we inspected the provider and the overall outcome was inadequate. As a result of the inspection, we have issued a Welfare Requirements Notice. This is a legal notice that requires the provider to take the actions below within the timescales set out. The provider will be able to give parents further information about this. The provider is still registered with Ofsted.

Action

Please see the inspection report dated 22 March 2019 for the full list of actions the provider was required to meet.

On 23 April 2019, we visited the provider and found that all staff had a Disclosure and Barring Service check in place. They also had supervision meeting with all staff. All registers were completed. Actions plans are in place to meet other welfare requirement notices. The next step will be further monitoring.

On 17 May 2019 we received a concern about the safety of children during the collection from school. On 21 and 23 May 2019 we conducted unannounced visits to discuss the matter in more detail. The provider has made satisfactory progress on the notices set at inspection. We have issued a further Welfare Requirements Notice. This is a legal notice that requires the provider to take the actions below within the timescales set out. We will monitor the provider.

Ensure staffing arrangements meet the needs of all children and ensure their safety, that staff are deployed effectively and children are adequately supervised. Children must usually be within sight and hearing of staff and always within sight or hearing. 4 June 2019

Ensure that all staff are received appropriate training and support to have a clear understanding of their roles and responsibilities. 4 June 2019

Ensure children are not exposed to risks of harm and demonstrate how all staff manage that risk, including how all safety procedures are implemented consistently. This refers to the



taking and collection of children from school. 4 June 2019

Promote the good health of children, with particular reference to ensuring sun safety procedures adequately protect children. 4 June 2019

Ensure children's hours of attendance are recorded accurately. 4 June 2019

Ensure any written complaint is responded to within 28 days of having received the complaint. 4 June 2019

On 5 June 2019 we conducted an unannounced visit and found that the most recent actions had been addressed. At the visit we issued another Welfare Requirements Notice that required the provider to

Implement the procedure, for responding to children who are ill or infectious, take necessary steps to prevent the spread of infection, and take appropriate action if children are ill. 17 June2019

On 14 June we received further concerns that the provider was not meeting requirements. On 20 June we conducted a full inspection.

At the inspection we suspended the provider's registration because we believed children may be at risk of harm. Suspension allows time for the provider to take steps to reduce or eliminate the risk of harm to children. Please see the published inspection report for further detail.

On 23 July 2019 we took steps to cancel the provider's registration. The provider had the right to appeal to an independent external tribunal, the Health, Education and Social Care First-tier Tribunal. No such appeal was received and the provider's registration has been cancelled. The provider is no longer registered with Ofsted.
