Summary of key findings for parents

This provision meets requirements

- The management team demonstrates a good understanding of its roles and responsibilities to keep children safe. Effective recruitment and induction processes are in place to check and maintain staff's suitability to work with children. All staff are required to complete regular safeguarding training to help them understand the procedures to identify and report any concerns regarding the welfare of children.
- Risk assessments are in place to help minimise hazards while children are indoors and on any planned outings. Staff regularly practise the fire evacuation procedure so they know what to do in an emergency.
- The management team has a strong overview of the setting and it regularly reflects and reviews to plan for future improvements. Feedback from parents and children is used to help identify any areas of improvement.
- The management team describes the value it places on partnership with parents. It recognises its influential role and the importance of gathering and sharing information to ensure the needs of children are met.
- The management team knows how to take into account children's individual needs and interests, in order to plan a wide range of activities for all children.
- The management team has a supervision and appraisal system in place. The manager undertakes regular training and arranges professional development for the staff to help them develop their skills and knowledge.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at a sample of documentation, including policies and procedures and evidence for the suitability of staff working at the club.
- The inspector had a tour of the premises where childcare is provided.
- The inspector spoke to the provider about their understanding of safeguarding and child protection.
- The inspector discussed with the provider how they intend to deliver the learning and development, and the safeguarding and welfare requirements of the early years foundation stage.
- The inspector discussed with the provider methods of self-evaluation and how they plan to promote improvements to the club.
