Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This secure children's home is operated by a voluntary organisation and is approved by the Secretary of State to restrict children's liberty. The children's home can accommodate up to 12 children who are aged between 10 and 17. The home provides for children accommodated under section 25 of the Children Act 1989, who are placed by local authorities.

Admission of any child who is under 13 years of age requires the approval of the Secretary of State, under section 25 of the Children Act 1989.

The commissioning of health services in this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided onsite in dedicated facilities.

The manager has been registered with Ofsted since March 2007.

This monitoring visit

Ofsted inspected this home on 9 and 10 July 2019 and judged the service to be inadequate. Because of this inspection, Ofsted served three compliance notices on 16 July 2019.

The purpose of this monitoring inspection was to review the progress made against these compliance notices relating to the protection of children, leadership and management and behaviour management records.

Children are much safer than previously reported. A deputy manager now has delegated responsibility to ensure that information within referral documents is clarified and incorporated into children's care plans, risk assessments and behaviour management plans. These documents are frequently discussed, reviewed and updated at handovers, briefings and weekly case management meetings. This



approach ensures that staff have accurate and up-to-date information that is used to meet each child's individual needs and manage effectively their known and emerging behaviours, risks and vulnerabilities.

Improved records mean that children's specific needs are considered when using physical restraint. As a result, children are much safer because staff are using techniques that take account of factors such as specific health issues.

New monitoring systems have been introduced and are being implemented effectively by all levels of management. These systems have brought about improved accountability for managers who are much clearer about their roles and responsibilities. The effectiveness of these systems is evident through improved management of admission information and significantly improved behaviour management records and practice.

There is an improved approach to identifying and providing needs-led training. For example, in addition to autism spectrum disorder training, staff have completed training specific to the needs of children admitted since the last inspection, such as managing diabetes, epilepsy and foetal alcohol syndrome. This has enabled staff to understand and respond more effectively to each child's needs, behaviours, risks and vulnerabilities.

Due to the short period of time since the full inspection, it is difficult to assess the long-term impact of these changes. However, the steps taken so far provide a strong platform upon which to improve.

Statutory requirements

Specifically, improve the facilities for carrying out personal searches to ensure that they strike an acceptable balance between security and the child's right to privacy.

Recommendations

Review education quality-assurance and quality-improvement processes urgently so that leaders and managers rectify weaknesses rapidly to ensure that children receive a consistently high quality of education.

Further improve the quality of teaching, learning and assessment so that it is at least good across the whole provision, and that all lessons are well planned, engaging, and meet the needs, abilities and interests of all children, particularly the most able.

Further improve the quality of information that teaching staff have on the educational starting points of children so that they set appropriate and challenging targets for children that help them to achieve their full potential.

Improve staff development activities so that staff receive appropriate training to improve their teaching practices and behaviour management strategies.

Further develop the curriculum offer to ensure that learning programmes help children to develop the skills, knowledge and behaviours that improve their life chances and help them to progress successfully to their next stages of

Ensure that all education and care staff have the highest expectations of what children can achieve.

Continue to improve attendance and limit even further the amount of time that children spend away from learning.
