Summary of key findings

This provision meets requirements

- The childminder has a good understanding of the early years foundation stage requirements. She knows how to assess children's development and plan activities to help them make progress in their learning.
- The childminder includes the views of parents and children to help evaluate her practice. She completes further training to help continually improve her knowledge and skills. This benefits children in her care.
- The childminder has a secure knowledge of safeguarding procedures. She is able to recognise signs of potential abuse and knows how to escalate concerns about the welfare of a child.
- The childminder knows how to provide a safe and stimulating environment. She provides a wide array of resources and activities to help promote children's understanding of one another's cultures, similarities and differences.
- The childminder understands the importance of play and sharing books to help develop children's early communication skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
