What is it like to attend this early years setting?

The provision is inadequate

The weak quality of teaching has had an impact on children's care and learning. Staff working with babies do not support their communication and language skills well. They fail to respond when babies communicate a word to them and interrupt their play to introduce concepts beyond their understanding. They miss opportunities to sing songs and rhymes during everyday routines and do not repeat simple words or sounds for babies to recognise. Staff do not allow time for toddlers to practise being independent and try things out for themselves. During mealtimes they miss opportunities such as allowing children to try feeding themselves or pour their own drinks. Some staff take over when toddlers are trying to put their coats on to play outside. They limit children's opportunities to develop essential skills for their future. The pre-school becomes very noisy and chaotic at times. This means that children are not able to concentrate and learn. Some activities are uninspiring, and older children become bored and restless. Consequently, children are not supported to develop skills to enable them to prepare for their eventual move on to school.

What does the early years setting do well and what does it need to do better?

- The registered provider does not have an adequate oversight of the quality and standards at the nursery. The supervision arrangements for staff are not effective. This has resulted in weak quality of teaching and inconsistent practice. The provider has not sustained the progress identified at the last inspection. There have been some improvements to safety arrangements, such as the security of the premises. However, these improvements are made in a reactive way as a result of incidents, rather than in a proactive way to avoid incidents occurring. The nursery has experienced a high staff turnover and a recent change in leadership. The newly appointed manager expresses a desire to make the necessary improvements.
- Staff do not always engage in conversations with older children to motivate and encourage them. They miss opportunities to captivate children's interests. During creative activities, they sit at the table, but do not follow children's interests or ideas. The activity lacks direction and purpose and children quickly lose interest. Staff working with older children do not understand their roles in helping children to prepare for their move to school. Children often become bored and turn to visitors or managers for attention.
- Staff deployment is weak. Staff do not identify when they need to adjust where they are placed to meet the individual needs of children and keep them safe. In the garden, they fail to notice risks to children. There are times when children become upset, staff do not notice, and visitors intervene to ensure children's needs are met.
- The lack of stability in staffing has resulted in weak key-person arrangements.



Staff do not always fulfil their role in helping children to feel settled and secure. For example, they do not always offer the close physical comfort needed when babies are upset. Sleep-time routines do not offer a cosy settled atmosphere for babies and younger children. Adults call across the room and switch lights on and off when children are settling down. Other children run around and do not settle well due to the poor routine.

- Parents spoken to at the inspection say that they appreciate the feedback they get from staff at the end of the day. However, the provider has not ensured that the complaints procedure is followed effectively to address concerns raised by other parents.
- The provider has not ensured that staff have a good understanding of child development. The weaknesses in the quality of teaching identified at the inspection are evident across all age groups. This means that the nursery does not provide a standard of education that enables all children to develop the skills they need for their future lives.

Safeguarding

The arrangements for safeguarding are not effective.

The provider does not follow safe recruitment procedures to check that staff are suitable for their role. Staff do not identify and remove all potential hazards or risks in order to keep children safe. On several occasions during the inspection the inspector identified risks to children's safety that staff did not see, for example, when rooms become cluttered and when children walk while they are eating, which increases their risk of choking. Furthermore, staff arrange activities such as balancing games without considering how they can reduce the likelihood of children becoming hurt.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.
