Inspection judgements

Overall experiences and progress of children and young people: requires improvement to be good

Three children currently live at the home. The four children who were residing at the time of the last inspection have moved on and four other children have been admitted and discharged. Records kept of admissions and discharges are incomplete, and do not include the date on which one of the children was discharged. There is no record of one of the children being admitted. Failure to provide accurate records makes it difficult to maintain accountability and demonstrates poor monitoring.

Some of the children have made good progress and benefited greatly from their placements. However, some of these placements have been ended prematurely after the children were discharged directly from police custody. This means that children have not been prepared to move on, and have not been given the opportunity to leave the home in a positive way.

When transitions are planned, they are good. A child who recently moved on to semi-independence said, 'Staff helped me so much. My life is now back on track. To be perfectly honest, I doubt that I would be alive if it wasn't for the help and support that they gave me from beginning to end. I start college soon and I completed my level 2 (qualification) while at the home. I have no complaints.'

Staff recognise the importance of education. Children who previously did not engage in education now have high attendance. Good progress has been achieved in this area. Two of the children attend the provider's school full-time and another child has just started a college course. The staff consistently encourage the children to visualise a successful future.

Children's meetings are held regularly. Staff encourage children to take an active part by chairing and recording minutes. The staff seek children's views, and realistic wishes and wants are followed through.

Children benefit from having access to in-house therapy from the provider's attending psychologist. Alongside this, key workers undertake good-quality work with the children, and encourage them to participate in activities and find positive hobbies. Consequently, children improve their confidence while learning new skills.

How well children and young people are helped and protected: requires improvement to be good

Staff are skilled in de-escalating challenging behaviour. This has led to a decrease in the number of physical interventions. There have been nine recorded physical interventions since the last inspection. However, a further intervention occurred that was incorrectly



recorded. Additionally, records of incidents reveal gaps in management oversight and do not consistently show that debriefs are being undertaken with the staff. Inaccurate and incomplete information fails to ensure that risks are effectively evaluated.

Several of the children have a significant history of going missing. The staff are proactive in locating children and follow missing-from-home procedures to ensure their safe return. However, on two occasions, a child who required one-to-one supervision went missing during a lapse in monitoring. Failure to implement risk assessment guidance does not protect children effectively from harm.

All staff who were spoken with during the inspection had a good understanding of safeguarding procedures. The designated officer confirmed that they have no concerns regarding practice, and have been contacted appropriately for advice and guidance. However, no notification was sent to Ofsted following an incident that was reported to the designated officer. Failure to notify Ofsted of significant events prevents the regulator from having effective oversight of the management of incidents at the home.

Children said that they feel safe living at the home. It is evident that they have formed positive relationships with staff. Appropriate banter is used. Staff consistently challenge any negative behaviour.

Some of the children are in the process of undertaking sessions with youth offending services. One of the youth workers who visits weekly said, 'Staff support and cope very well with [the child's] challenging behaviour. The staff are very accommodating. They encourage and facilitate a working space. This helps me to do my job effectively and [the child] is doing amazingly.'

The effectiveness of leaders and managers: requires improvement to be good

The registered manager left her position in April 2019, and another manager was appointed in the same month. This manager subsequently left and the home was being overseen by senior managers until the new manager started in August 2019. The numerous changes of managers since the last inspection have resulted in inconsistent managerial oversight of the home.

Monitoring and evaluation of incidents have weakened. The new manager and the dedicated staff place the needs of children at the centre of their practice. Good practice is evident in several areas, but record-keeping has not been consistently sustained and is therefore not effective. The provider and the new manager are fully aware of the shortfalls in record-keeping, and have made this a priority in the home's immediate development plan.

Several members of staff have not received regular supervision, and have not had timely yearly appraisals. This means that the staff are not afforded opportunities to regularly reflect on their practice, and their personal development is not being fully overseen.



All the staff are up to date with the organisation's mandatory training, including safeguarding and physical intervention training. However, two staff members have not achieved a relevant level 3 qualification within the required timescales.

Good relationships with families and professionals have been maintained. All the families spoken with during this inspection were very complimentary about the care provided. Family members commented on the evident commitment of staff and the good care that they provide, which enables the children to make progress.

The independent visitor makes recommendations following their monthly visits. The reports are comprehensive and detailed. The reports now contain an independent view on the children's well-being and an opinion on safeguarding standards at the home. However, the reports do not consistently demonstrate that there is consultation with parents, social workers and staff.

The two requirements raised at the last inspection have been restated. Three of the four recommendations have been met effectively. The unmet recommendation relating to record-keeping shortfalls is now a requirement.

Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
