Summary of key findings

This provision meets requirements

- The childminder has a robust understanding of how to keep children safe. She knows the signs and symptoms of abuse, and who she would report any concerns to, including allegations made against herself or a household member.
- The childminder understands the learning and development requirements of the early years foundation stage. She has continued to access training to keep herself updated with changes in policy and legislation.
- The childminder describes how she will plan a broad curriculum. She will provide activities that build on what children already know, and what they need to learn, to help prepare them for the next stages in their development.
- The childminder explains how she has high expectations for children's behaviour. She will help children to manage their own feelings and support them to follow the clear rules and boundaries she will set.
- The childminder understands how to promote children's resilience and independence. She will provide opportunities that encourage children to have a go and to try things for themselves.
- The childminder knows the value of working in partnership with parents, other childcare providers and outside agencies, to meet children's needs and ensure continuity in their learning and development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
