What is it like to attend this early years setting?

The provision is good

Children form strong attachments to the childminder, who helps them to settle well into her routines. Children play happily and can choose their favourite toys independently.

The childminder is sensitive to the needs of each child and supports their learning effectively. For example, she monitors children's sleeping time frequently and helps to ensure that children have space to relax and to sleep comfortably.

Children have access to good learning experiences. For example, they keenly mix the different-coloured paints and observe how colours change when they mix. Children love to show their artistic work to the childminder, who offers them praise and reassurance as they play.

The childminder keeps parents well informed about their children's learning and development and involves them in planning the next steps. She also seeks their views to help improve her service.

The childminder has established close links with other providers to help ensure that children receive good continuity and progression to their learning and development. She also keeps records such as contracts and information on all children she cares for.

At times, the childminder misses the opportunity to extend children's mathematical skills and how to solve problems unaided.

The childminder does not always provide enough opportunities for children to fully develop their technology skills.

What does the early years setting do well and what does it need to do better?

- The childminder has a good understanding of how children learn and develop. She gathers relevant information from parents to help her assess children's learning and to plan activities that motivate children to learn. Children who have speech and language difficulties achieve equally well.
- The childminder plays with children and encourages them to use their imagination well. Children enjoy their time with the childminder. For example, younger children show interest in water and bubbles. Older children purposefully build their favourite models and learn to use resources safely.
- The childminder reads stories to children and helps them learn new vocabulary. Children keenly take part in songs and rhymes. However, the childminder does not consistently extend children's mathematical skills and the ability to solve



simple problems for themselves.

- Children are excited to explore resources and to find out how things work. However, they do not always have enough access to tools to aid them to develop their technology skills.
- The childminder talks to children in a calm manner and supports their social and emotional skills to good effect. She also shares her behaviour code of conduct with parents and children so that they are clear about her expectations. Children learn to share toys, listen attentively and demonstrate good attitudes to learning. Their behaviour is good.
- The childminder helps children to develop healthy living. For example, she encourages children to wash their hands before meals. Younger children love to socialise with others and enjoy eating alongside them. Children enjoy healthy snacks and learn to serve themselves. They understand that they need to drink water to keep them hydrated as they play outdoors. Children appreciate the outdoor play and develop good physical skills as they climb and slide on the apparatus.
- Children enjoy the natural world. Older children are developing a good understanding of how the weather changes around them. They make good comments, for example, on how the flowers in the childminder's garden are still flourishing.
- Through outings and celebrations of different festivals, children learn about their own identity and the wider world around them.
- The childminder attends courses to widen her skills. She is confident to seek advice from outside professionals to help her meet the needs of specific children.

Safeguarding

The arrangements for safeguarding are effective.

The childminder has a good knowledge of child protection matters and understands the reporting procedures to protect children in her care. She shares her policies and procedures with parents so that they know how to keep children safe. The childminder undertakes checks on outings, her home and toys to help children remain safe.

What does the setting need to do to improve?

To further improve the quality of the early years provision, the provider should:

- provide a suitable level of challenge to extend children's mathematical skills and their ability to solve problems independently
- broaden the range of opportunities to aid children to develop their technology skills as part of their knowledge and understanding of the world around them.
