Information about this children's home

The children's home provides care and accommodation for up to 14 children or young people who may have physical disabilities, learning disabilities and/or a sensory impairment. The accommodation consists of a residential unit and a three-bedroomed cottage. A private provider operates the home. There is no registered manager in post.

Inspection date: 3 September 2019

This monitoring visit

This children's home was judged inadequate at the full inspection on 12 and 13 June 2019. The purpose of this monitoring visit was to inspect and review a compliance notice.

The provider has met the steps set out by Ofsted to meet the requirements of the compliance notice. As a result, leadership and management outcomes are improved.

The provider has focused on recruiting a new manager to provide consistent management oversight and stability. Improvements in how the home is monitored strengthens the development of the home and the outcomes for the children and young people.

Staff training and induction for new staff are better organised to ensure that the staff receive the training they need. Arrangements for longer-term training are set out in an action plan, which demonstrates that the provider is invested in supporting staff development.
