## **Summary of key findings**

#### This provision meets requirements

- The childminder has a secure knowledge of safeguarding and has appropriate policies in place. She is able to recognise signs of potential abuse and knows how to escalate concerns regarding a child's well-being.
- The childminder values working in partnership with parents to build continuity of care for children.
- The childminder has a good understanding of the early years foundation stage requirements. She understands how to assess what children can do in order to help plan activities that will enhance their development.
- The childminder knows how to provide a safe environment for children to explore in order to help them to make progress in their learning.
- The childminder ensures that she promotes positive behaviour and children's well-being, and supports them to develop their self-confidence. She understands the importance of helping children to value one another's similarities and differences.
- The childminder understands the benefit of developing her professional practice to enhance children's learning experiences. She liaises with the local authority to help keep her skills and knowledge up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
